Preface & Goal

LeadingAge Wisconsin, formerly WAHSA, is a statewide membership organization of not-for-profit corporations principally serving seniors and persons with a disability. Membership is comprised of 188 religious, fraternal, private and governmental organizations which own, operate and/or sponsor 185 nursing homes, 9 facilities for the developmentally disabled (FDD), 182 assisted living facilities, 114 apartment complexes for seniors, and over 300 community service agencies which provide programs ranging from Alzheimer's support, adult and child day care, home health, home care, and hospice to Meals on Wheels. LeadingAge Wisconsin members employ over 38,000 individuals who provide compassionate care and service to over 48,000 residents/tenants/clients each day.

LeadingAge Wisconsin has prepared this report to document the chronic underfunding of Wisconsin's nursing facilities. Our goal is to secure additional Medicaid funding to address the needs of Wisconsin's most frail and vulnerable citizens and to maintain the quality of care and life our nursing facility residents require and deserve.

A solution is available to address the well-documented underfunding of Wisconsin's nursing facilities: Return the nursing facility bed tax "skim" resulting from the imposition of the \$170 per licensed nursing facility bed per month State bed tax. Approximately \$45 million of federal funds generated annually by the bed tax is not used to fund

nursing facility care but rather is "skimmed" to offset Medicaid base expenditures. Returning the bed tax "skim" in its entirety would significantly assist Wisconsin's nursing facilities in meeting the growing care and service needs of today's skilled care residents.

Wisconsin Nursing Facilities: Medicaid and Family Care Deficits for Payment Year 2011-12

The following report provides a nursing home *Fact Sheet* with utilization, financial and cost information on Wisconsin's nursing facilities. Following the *Fact Sheet* is LeadingAge Wisconsin's analysis of the Medicaid and Family Care deficits for each of the State's 381 nursing facilities for which Medicaid cost report information was available from the Department of Health Services. That information is listed by State Senate districts.

It is worth noting that approximately two-thirds (18,766) of all Wisconsin nursing facility

residents are Medicaid or Family Care recipients. As such, the underfunding of the cost of care by these pubic programs has a profound fiscal and programmatic impact on nursing facility residents and staff.

In the 2011-12 payment year, total facility Medicaid and Family Care deficits--the difference between the cost of care provided to residents and the amount of reimbursement provided by these public programs—totaled **\$355.9 million**. This deficit equates to

a loss of \$51.96 per day for each Medicaid/Family Care resident served, meaning the "average" nursing facility experiences an annual Medicaid/Family Care loss of over \$1.1 million annually. A stunning 98.95% of all Wisconsin nursing facilities (377 out of a total of 381 facilities) experience Medicaid/Family Care deficits. LeadingAge Wisconsin's analysis indicates that total Medicaid/Family Care facility losses actually increased by 10.1% from fiscal year 2011 to 2012.

The underfunding of nursing facilities has an impact on residents and staff. Labor costs represent approximately 70% of the total cost of providing care and treatment to nursing facility residents. Wisconsin nursing facilities employ over 52,000 individuals and 58% of these employees are direct caregivers (Certified Nursing Assistants, RNs and LPNs). Mounting Medicaid/Family Care losses make it extremely difficult for facilities to adequately fund the staff wages, benefits and staffing levels needed to ensure the provision of quality care.

2009 Act 28 increased the nursing home bed tax from \$75/licensed bed/month to \$150/licensed bed/month in 2009-10 and an additional \$20 increase to \$170/licensed bed/month in 2010-11. Using the federal funds generated by the nursing home bed tax

increases to offset Medicaid base expenditures, rather than for Medicaid rate increases for the nursing facilities generating those additional federal funds through the bed tax, has come to be known as the nursing home bed tax "skim."

As noted below, the bed tax "skim" has contributed mightily (\$260.5 million) to the State Medicaid budget:

Given the obvious financial challenges facing Wisconsin nursing facilities, it is time to divert the bed tax "skim" to the nursing facilities that are generating these dollars. The Governor's proposed 2013-15 biennial budget bill, Assembly Bill 40, would provide a much-needed 2% resident acuity funding increase in each year of the biennium. LeadingAge Wisconsin applauds and endorses this budget recommendation. This increase is in recognition of higher nursing facility resident acuity (i.e., a higher percentage of residents admitted with complex and often unstable medical conditions, challenging behaviors, in need of end-of-life care, or intensive rehabilitation or restorative care).

Under the Governor's proposal, recognizing higher resident acuity would cost \$13.1 million all funds (\$5.4 million GPR) in 2013-14 and \$25.5 million all funds (\$10.5 million GPR) in 2014-15.

Assuming these 2013-2015 increases are funded by a partial return of the \$45 million annual/\$90 million biennial bed tax "skim," the remaining bed tax skim would total approximately \$31.9 million all funds (\$12.6 million GPR) in 2013-14 and \$19.5 million all funds (\$7.6 million GPR) in 2014-15. It is these remaining \$20.2 million GPR/\$51.4 million AF bed tax "skim" amounts that LeadingAge Wisconsin urges elected officials to also return to nursing facilities. Doing so would offer significant and much needed fiscal relief to the struggling nursing home provider community.

Before presenting the *Fact Sheet* information, it is worth noting that the 2% resident acuity adjustment for nursing facilities in 2013 Assembly Bill 40 is not creating added financial pressure on the Medicaid budget. As shown below, under the Governor's budget proposal, the overall nursing facility (non-FDD) funding levels for fee-for-service Medicaid residents are actually projected to decrease by \$15.9 million all funds in 2013-14 and by \$23.5 million all funds in 2014-15, even after the resident acuity adjustments are made.

Summary Statement

Without question and under any measure, Wisconsin nursing facilities are experiencing significant financial distress. LeadingAge Wisconsin respectfully seeks the return of the \$45 million annual/\$90 million biennial bed tax "skim" in the 2013-15 biennium to the nursing facilities that are generating these dollars. The Governor's proposed 2013-2015 biennial budget bill would provide a much-needed 2% resident acuity funding increase in each year of the biennium. LeadingAge Wisconsin wholeheartedly supports this budget proposal and asks legislators to consider options to return the remaining bed tax "skim."

Fact Sheet: The Underfunding of Nursing Facility Resident Care

A comprehensive analysis of the nation's Medicaid nursing facility payment systems ranked the Wisconsin system the 4th <u>worst</u> in the country. The study, "Report on Shortfalls in Medicaid Funding for Nursing Center Care," released in December 2012 by Eljay, LLP, a national accounting and consulting firm, revealed that Medicaid deficits sustained by Wisconsin's nursing facilities are the fourth highest in the country (surpassed only by New York State, New Jersey and New Hampshire).

The national report and ranking came as no surprise to the Wisconsin nursing facility community. Indeed, the Wisconsin Medicaid program's own database of facility- specific cost and reimbursement information for 2011-12 (the most recent data available) vividly illustrates the system's inadequacies. It reveals the following:

- Medicaid recipients as of July 2012 (18,766 residents), including Family Care enrollees, comprise approximately 67% of all residents served in Wisconsin nursing facilities.
- Labor costs represent approximately 70% of the total cost of providing care and treatment to nursing facility residents. Nursing facilities employ over 52,300 individuals; 58% of all nursing facility personnel perform nursing care and services (RNs, LPNs, and certified nursing assistants).
- In the 2011-2012 payment year, the difference between the total cost of the care facilities provided their Medicaid residents and the Medicaid reimbursement they received for providing that care (i.e., the "Medicaid deficit") was \$332,540,494. When the additional \$23,363,264 in Family Care losses are factored in, the aggregate Medicaid/Family Care deficit is \$355,903,758, an increase of 10.1% over the previous year.
- Direct care costs, the costs to provide hands-on care to residents, represented \$200,065,742, or 60.2%, of the total costs Medicaid failed to reimburse in 2011-2012.
- Approximately 99%, or 377 of the 381 nursing facilities in the state's database, received a Medicaid payment in 2011-12 which failed to meet the cost of care they provided their Medicaid residents.
- Wisconsin nursing facilities, on average, lose \$51.96 per day for each Medicaid/Family Care resident they serve. For the average Wisconsin nursing facility, that results in an annual loss of \$1,125,700 to provide care to these residents.
- Despite this growing Medicaid deficit, 2011 Wisconsin Act 32, the 2011-13 state budget, contained no Medicaid rate increase for nursing facilities, although a 1% acuity adjustment was provided in each year of the biennium.

- Historically, nursing facilities have subsidized their Medicaid losses with revenues generated by Medicare beneficiaries and residents paying privately. In Wisconsin, approximately 67% of nursing facility residents are Medicaid/Family Care recipients; 21% are private payors; and the remaining 12% are Medicare beneficiaries.
- As a result of the failure of the Medicaid program to pay the resident care costs for which it is responsible, private paying nursing facility residents are compelled to pay rates that average an estimated \$90 per day higher than a facility's Medicaid payment rate (Average 2011-2012 Medicaid facility payment rate: \$152.96 per day) for virtually the same care a Medicaid resident receives. Despite that payment differential and the fact that Wisconsin private payors also must pay a \$170/month nursing facility bed tax, those paying privately for their nursing facility care continue to be asked to subsidize an even greater proportion of this Medicaid underfunding. When you combine those payment inequities with the ever increasing numbers of private payors spending down to Medicaid eligibility because of a challenging economy, it begs the question: How much longer can we rely on private paying residents to bail out the Medicaid program?
- The ability for nursing facility providers to use Medicare revenues to offset Medicaid losses also has been significantly curtailed. Why?: 1) The Patient Protection and Affordable Care Act in 2010 reduced Medicare expenditures for skilled nursing facilities (SNF) by \$14 billion over the next 10 years; 2) The federal Centers for Medicare and Medicaid Services (CMS) cut Medicare SNF reimbursement by an average of 11.1% on October 1, 2011 (because Medicare SNF reimbursement is based on resident acuity levels and the location of a facility, **the average Wisconsin SNF experienced a Medicare rate cut of 12.6%)**; and 3) Under Federal Sequestration, Medicare Part A payments to health care providers will be reduced by an additional 2% on April 1, 2013 (\$12.8 million annually). Nursing facility Medicare Part B payments also will by reduced by 2% on April 1, 2013.
- At least forty Wisconsin nursing facilities have closed in the past decade because of insufficient reimbursement, all prior to the imposition of these Medicare cuts.
- No one has ever accused a Wisconsin nursing facility of being overstaffed or its caregivers being overpaid. Indeed, the average Wisconsin nursing facility certified nurse assistant (CNA), the primary caregiver in a nursing facility, earns \$12.86/hour to care for some of the frailest and most vulnerable members of our society. How can we continue to provide quality care to our frail elderly and persons with a disability when we can barely provide a living wage to those who provide that care?
