



- 13 Technical colleges with approved nurse aide training programs
- 17 Nursing homes with approved nurse aide training programs
  - 9 Private nurse aide training programs
- 302 Nursing homes that agree to pay \$500 retention bonus
- **4,285** Students registered in WisCaregiver Careers
  - 988 Students registered for training
  - 413 Students completed training
  - 69 Students who dropped from training or failed
  - 294 Students who tested
  - 223 Students successfully passed on 1<sup>st</sup> attempt/on nurse aide registry
  - 16 Students successfully passed on 2<sup>nd</sup> attempt/on nurse aide registry
  - 104 WisCaregivers employed

# Changes from 2<sup>nd</sup> quarter:

- Nursing home training invoices more than doubled and technical colleges increased significantly. No invoices from private training programs for Q3.
- After 7 months WisCaregivers has expensed 20% of the total budget.
- Administrative budget is down to \$5,142 which does not include the honorariums from Workforce Solutions honorariums.
- Student registration up 60%
- Enrollment into training up 59%
- WisCaregivers employed up 845%
- We added 9 new private nurse aide programs during this quarter and lost one technical college (Madison College) and added one new employer.
- 76% of students passed on 1<sup>st</sup> attempt, 67% passed on 2<sup>nd</sup> attempt and 19% tested but did not pass.

# **DHS Internal Operations**

- **2,128** Mailbox responses
- 1,907 Number of criminal background checks processed
- 73 Number of checks that showed applicant on registry disqualifying the person

# Changes from 2<sup>nd</sup> quarter:

- 103% increase in mailbox correspondence from 2<sup>nd</sup> quarter
- 24% decrease in CBCs from 2<sup>nd</sup> quarter.

The overview page ranked as the 65th most visited page on the DHS site during this same time period, and it accounted for 0.23 percent of all DHS web traffic.

### Changes from 2<sup>nd</sup> quarter:

**DHS Webpages:** 

- Student page 9% decrease in page views and a 8 % decrease in unique page views
- Student page decreased slightly in most visited DHS site from 19<sup>th</sup> to 21<sup>st</sup>.
- Overview page 13% decrease in page views and a 12% decrease on unique page views
- Overview page decreased slightly in most visited DHS site from 51<sup>st</sup> to 65<sup>th</sup>.

#### **DHS Facebook and Twitter**

- Facebook 98% decrease in views
- Twitter 95% decrease in views


DHS decreased WisCaregiver postings on Facebook and Twitter due to backlog created by high registration and limited training capacity. Because DHS did not posting as often, DHS is no longer boosting posts and WBA is not having them shared with all TV and radio stations.

# Changes from 2<sup>nd</sup> quarter:

• Bimonthly registrations averaged 322 in the 3<sup>rd</sup> quarter compared to 283 in the second quarter representing a 14% increase.

# Changes from 2<sup>nd</sup> quarter:


- Age stayed relatively the same with the biggest swings representing an approximately 10% decrease in under 19 compared to an approximate 10% increase in 20-29 year olds.
- Race changed significantly with Q3 showing 29% applicants White, compared to 56% in Q2 and 65% applicants Black compared to 31% in Q2
- No significant difference from Q2 related to education.
- How they heard about WisCaregiver stayed relatively the same from Q2 with the biggest change Facebook & Twitter represented 25% compared to 16% in Q2
- Training enrollment decreased 45% from Q2 and shifted as follows:

- 745% increase in the number of WisCaregivers hired in Q3 compared to Q2
- The scatter Map shows increase density in many of the counties as more people register with the proportions staying relatively the same.




### **AGE RANGE**






#### HOW PARTICIPANTS HEARD OF THE PROGRAM
