

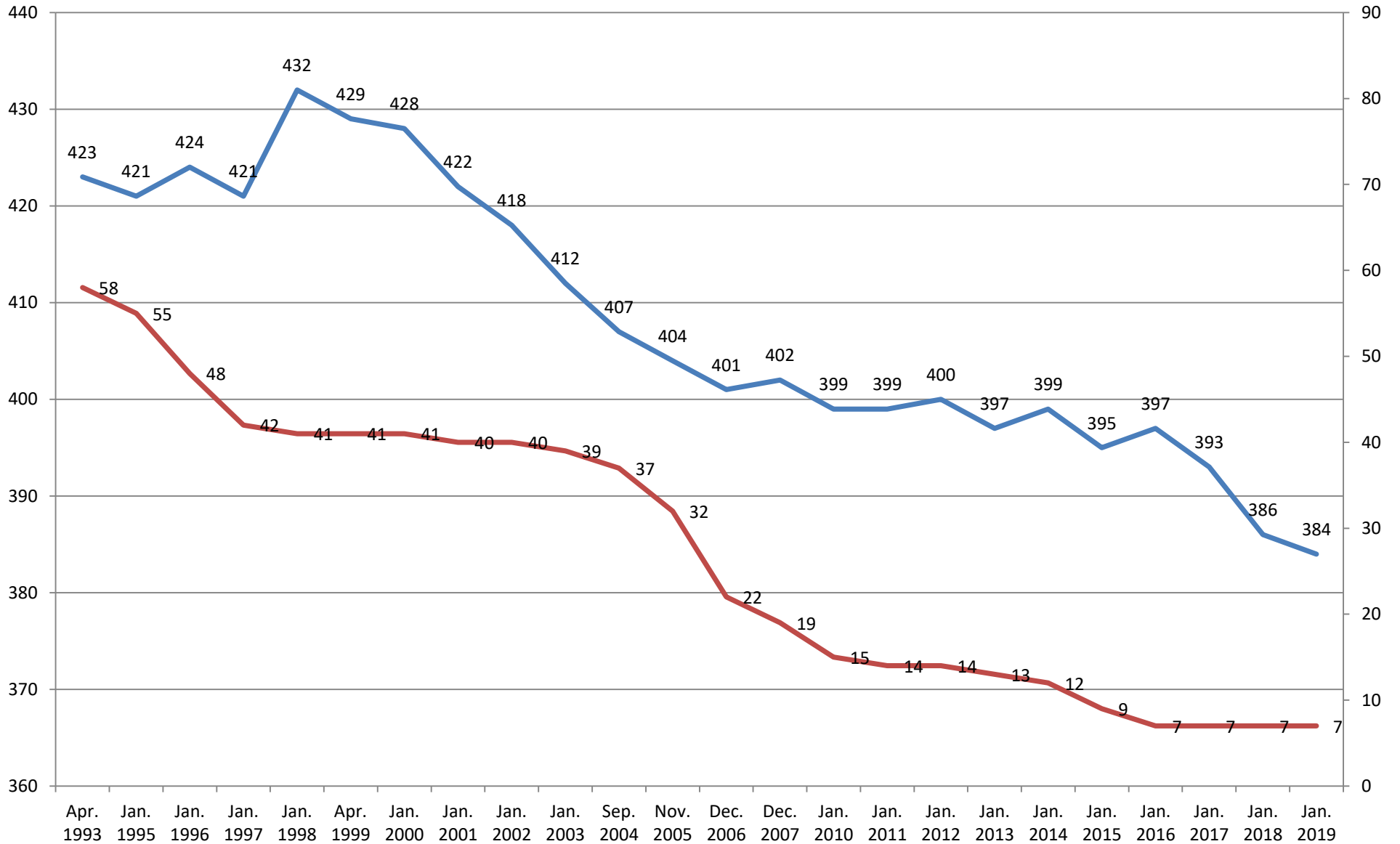

Number of Nursing Homes and Intermediate Care Facilities for the Intellectually Disabled

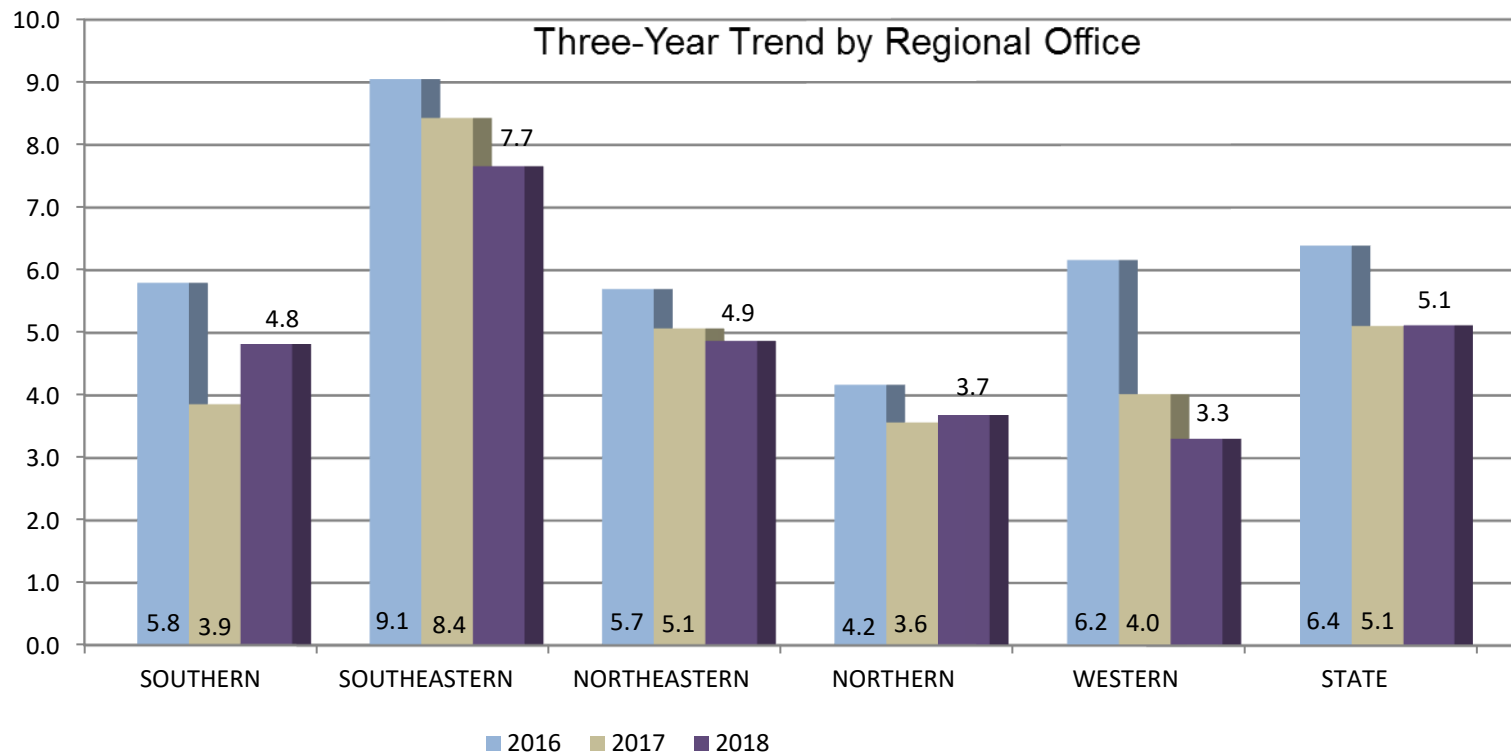
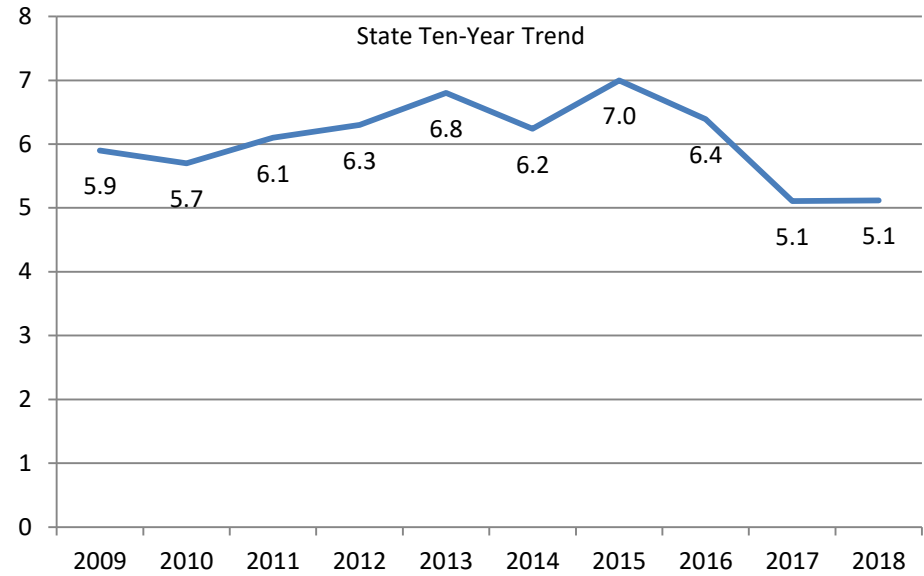

Average Number of Federal Health Citations per Recertification Survey

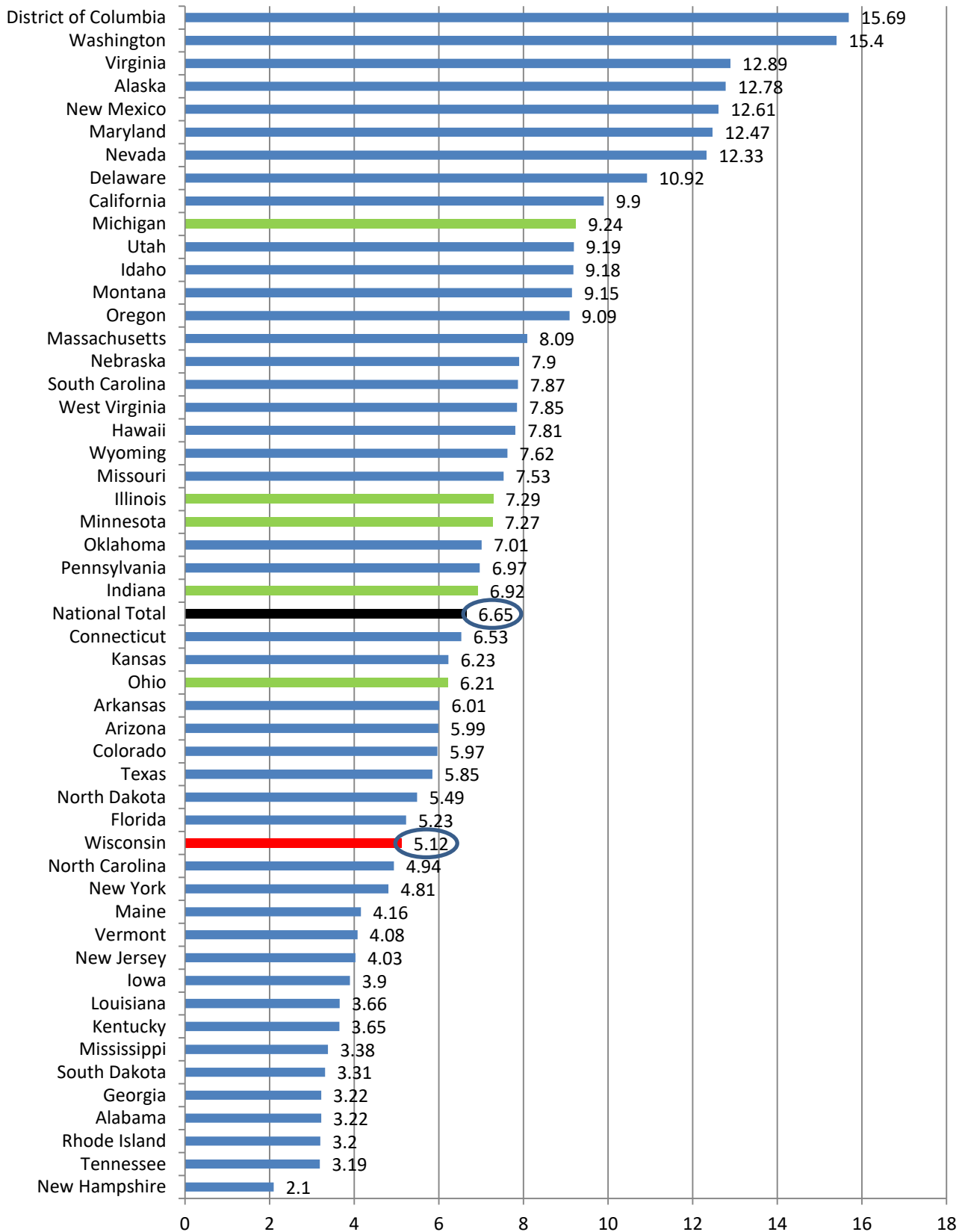

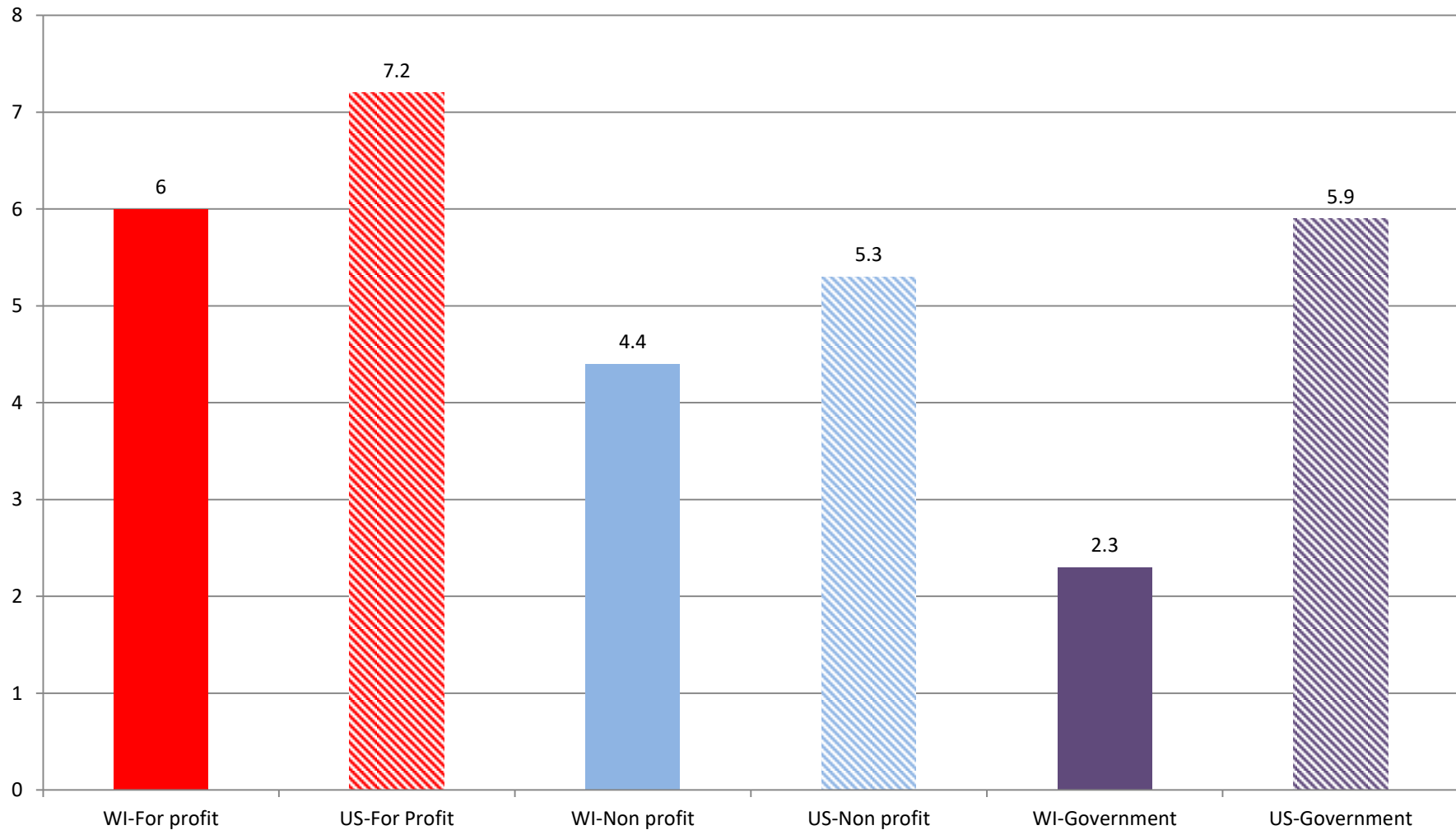

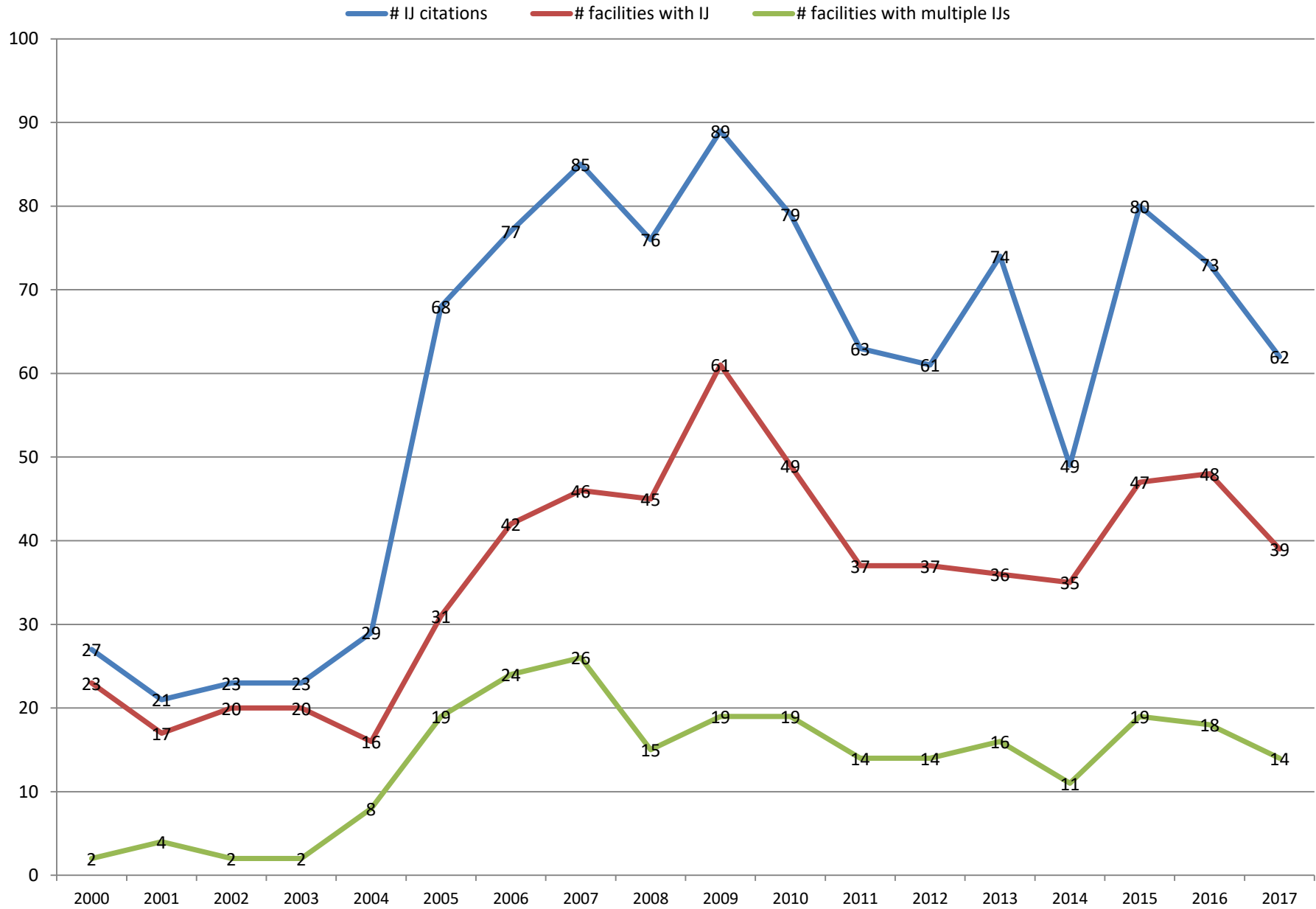
Average Number Federal Health Citations per Recertification Survey by Ownership Type 2018

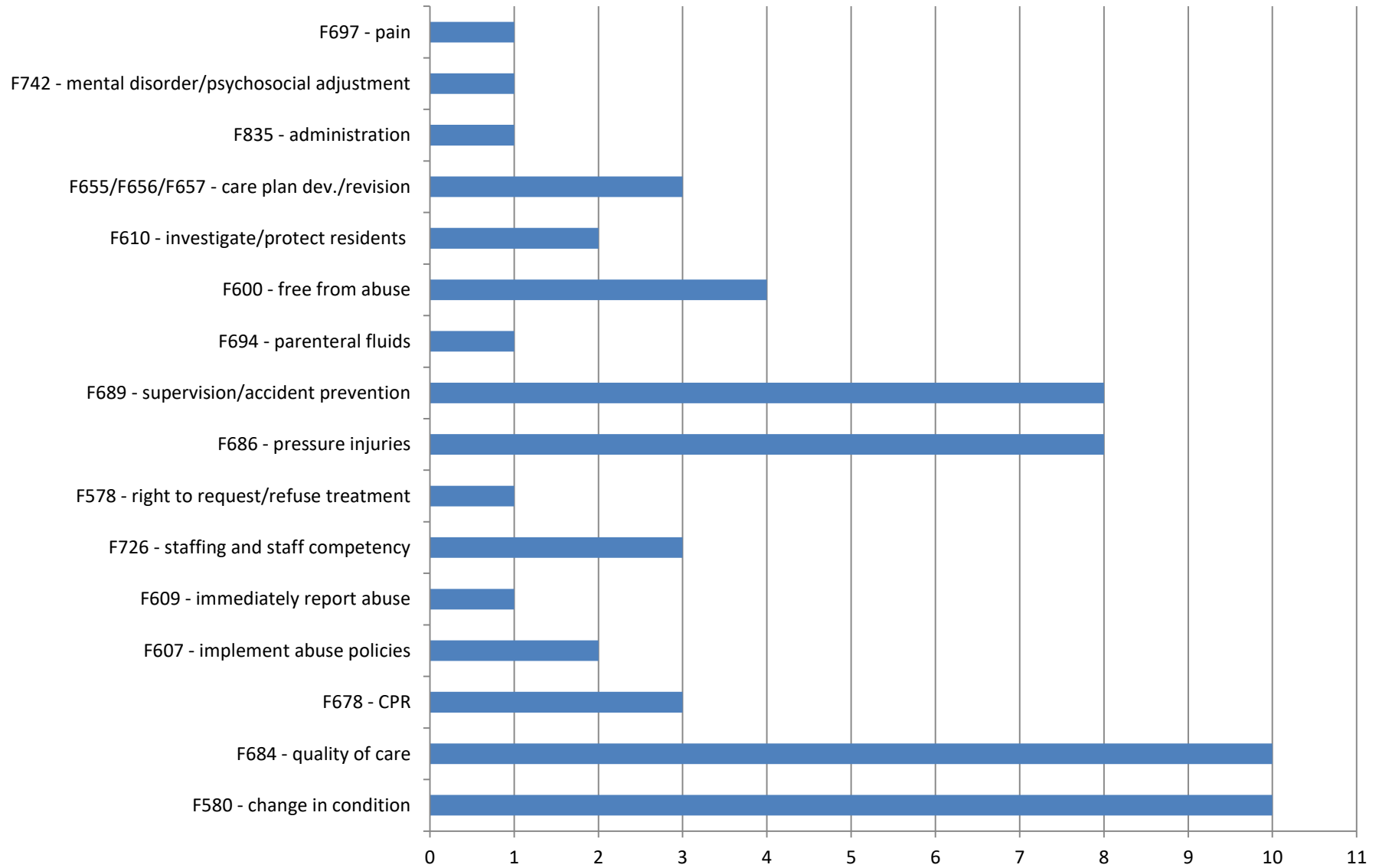


Immediate Jeopardy Citations 2005 - 2017





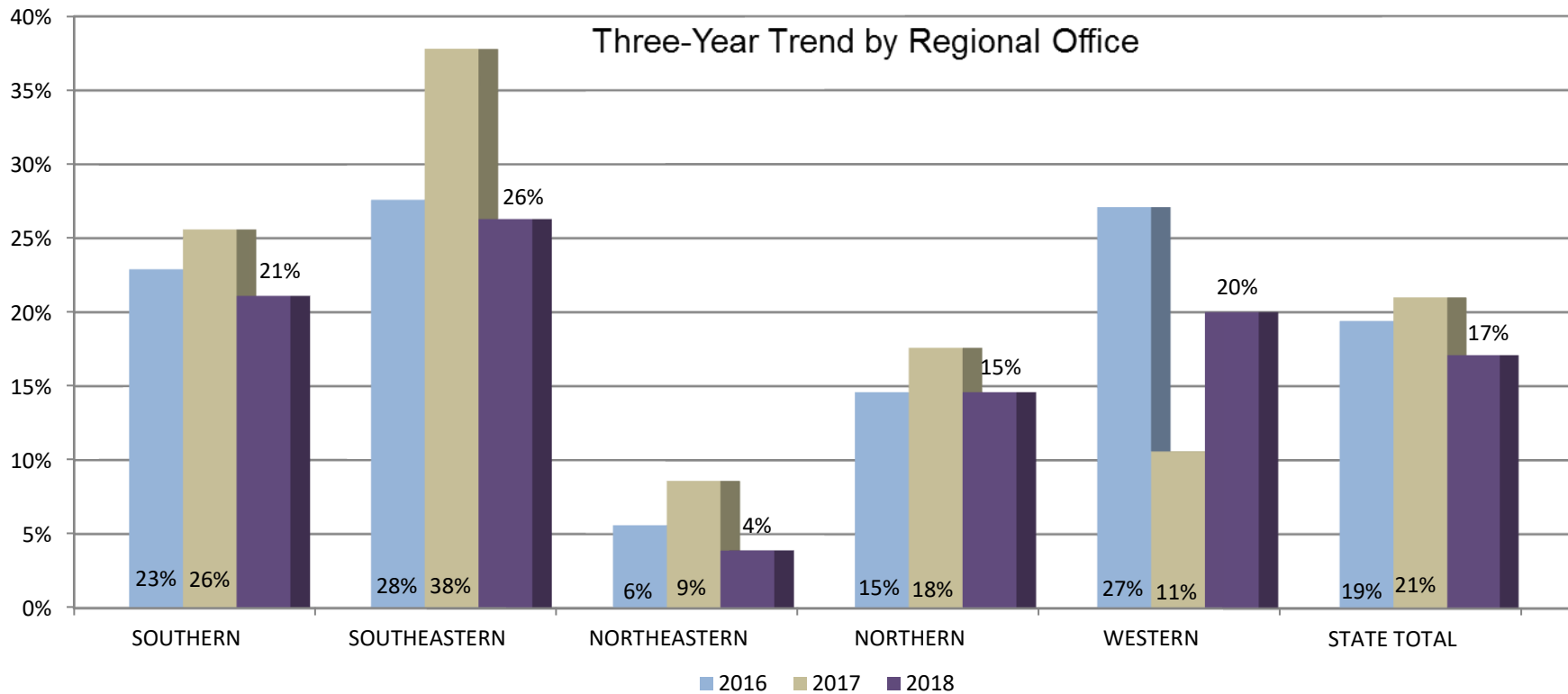
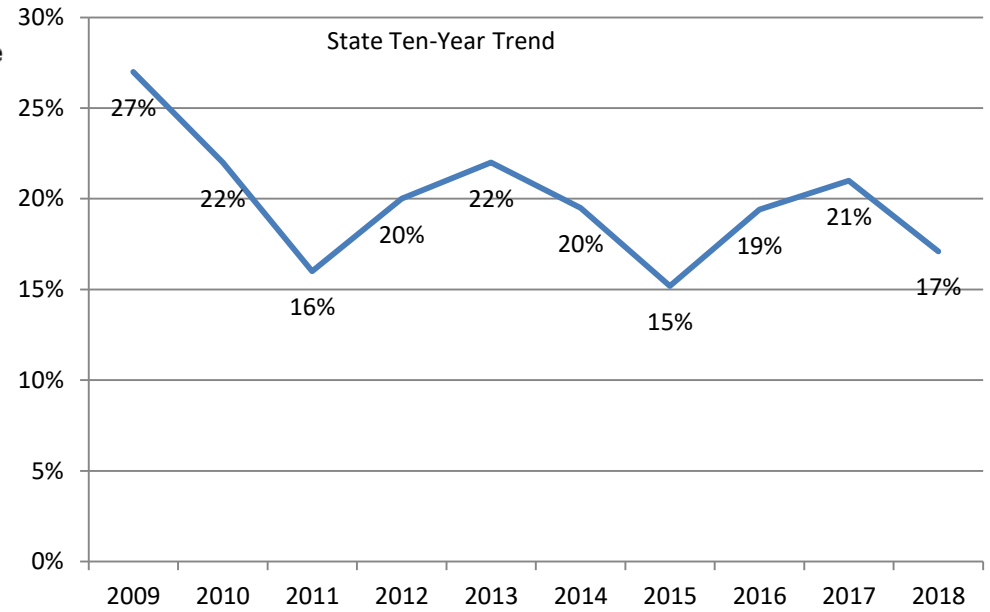
Federal Tags Cited at the IJ Level 2018





Percentage of Recertification Surveys with Harm or Immediate Jeopardy

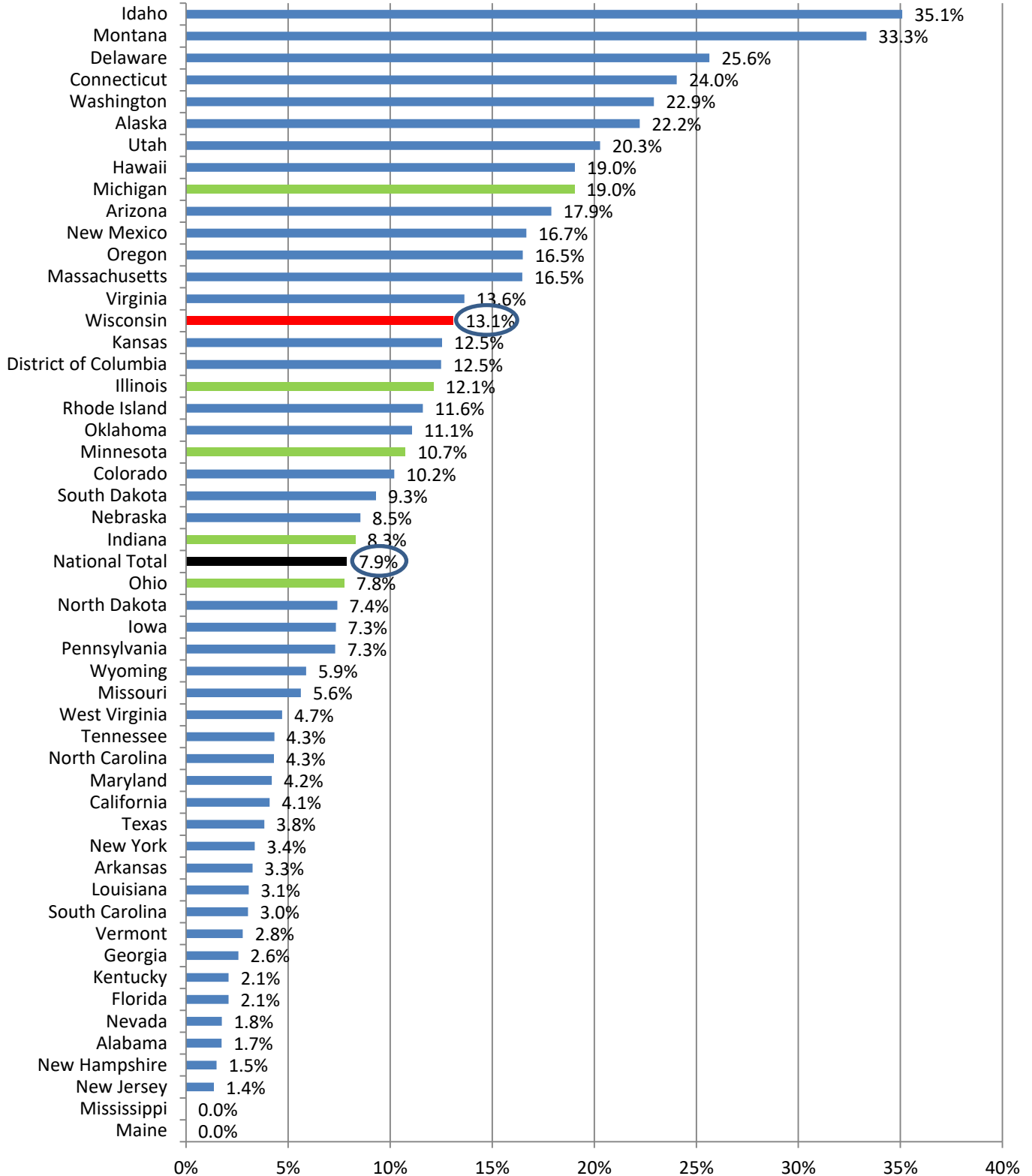

Percentage of Recertification Surveys with Actual Harm as Highest Scope/Severity

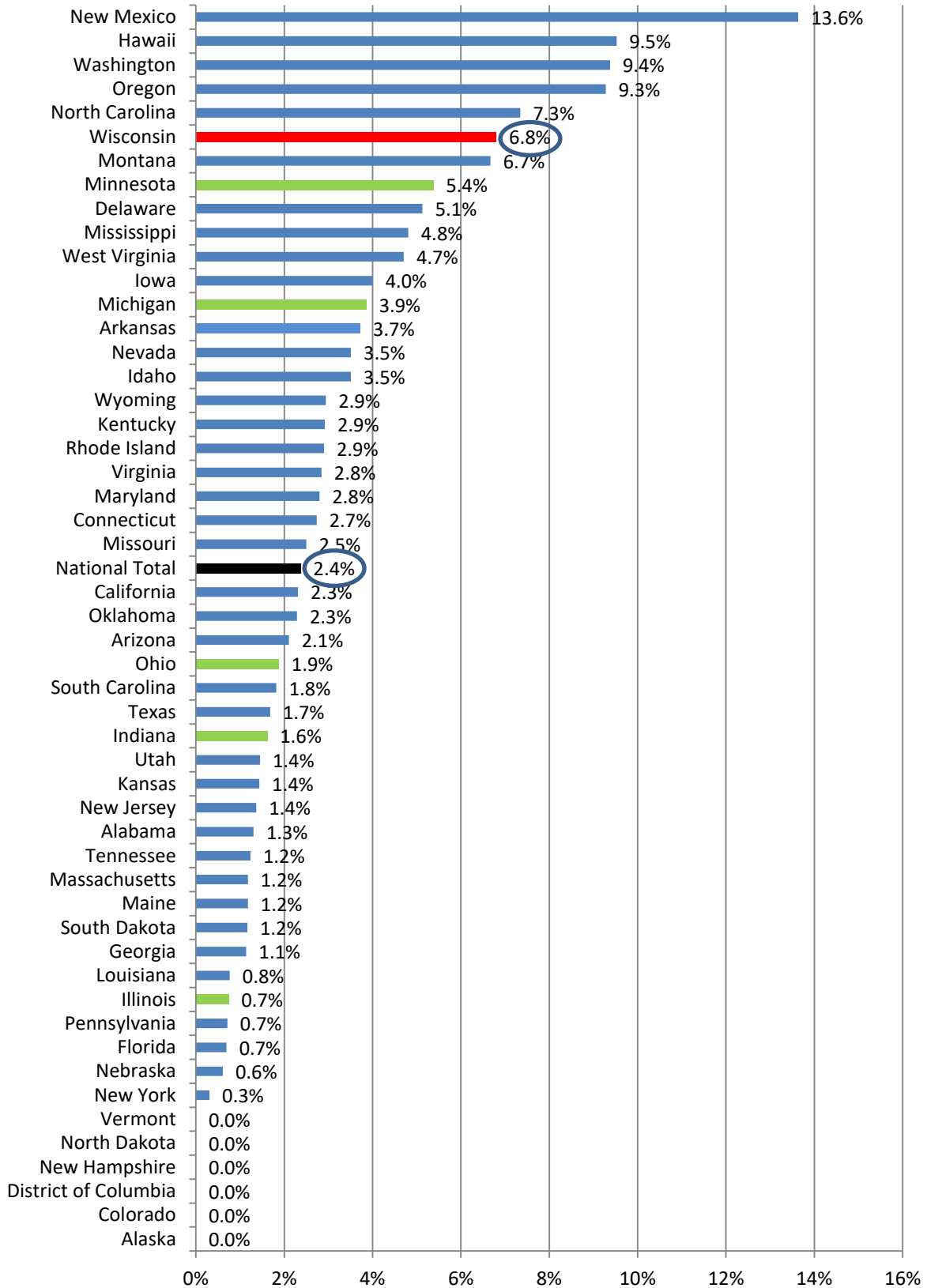

Percentage of Recertification Surveys with Immediate Jeopardy 2018

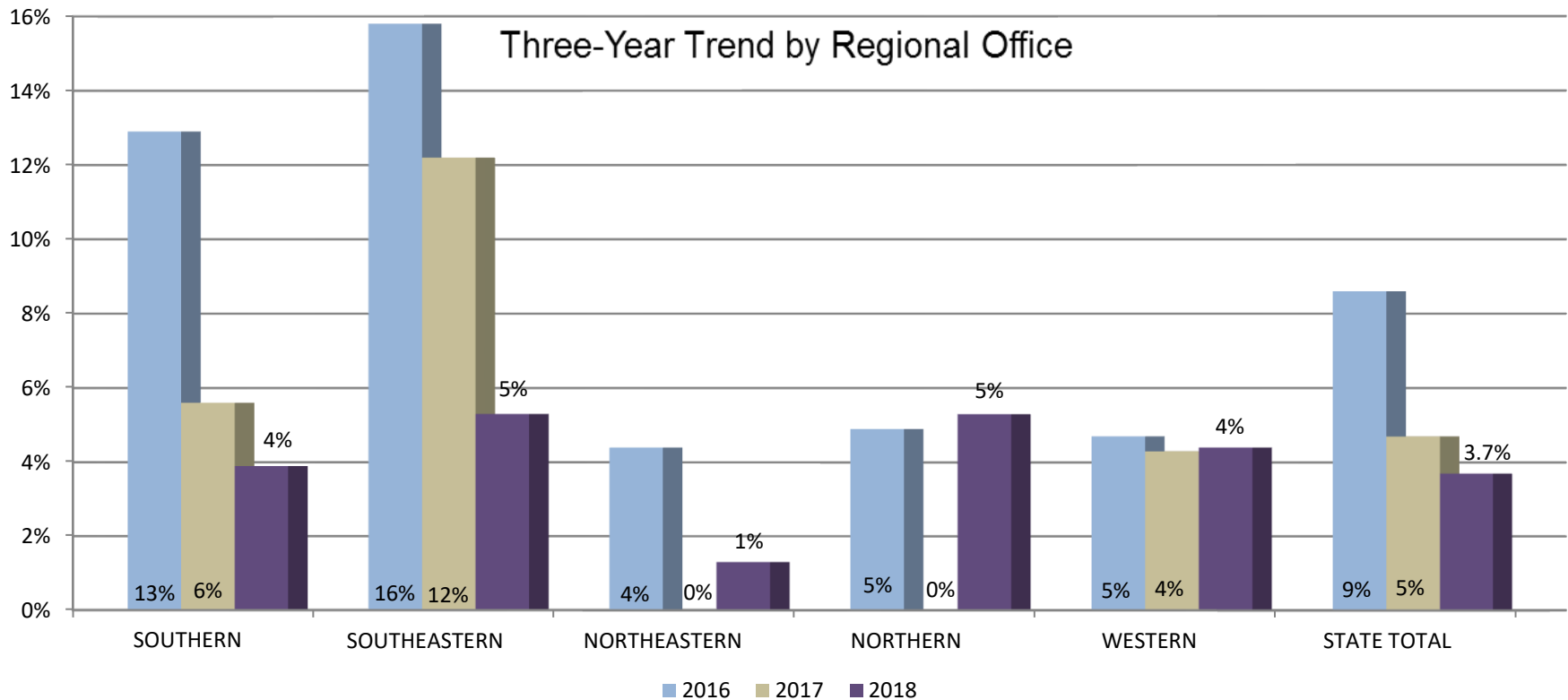
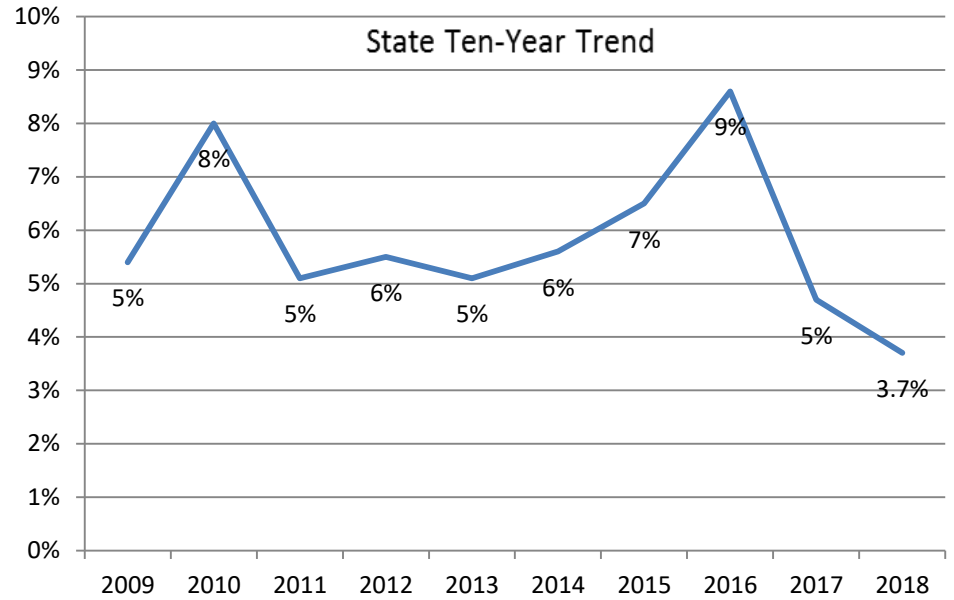

Percentage of Recertification Surveys with Substandard Quality of Care

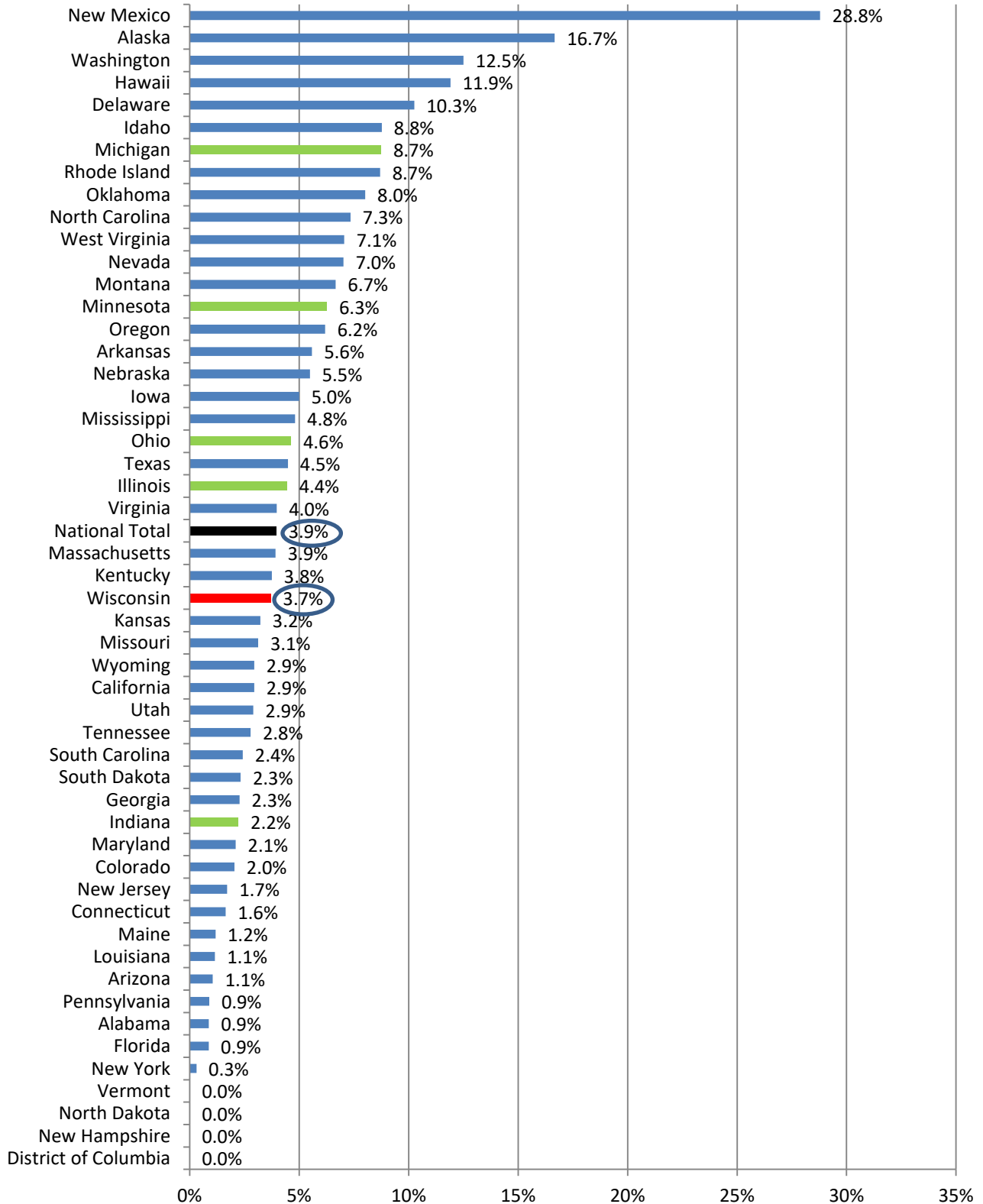

Percentage of Recertification Surveys with Finding of Substandard Quality of Care

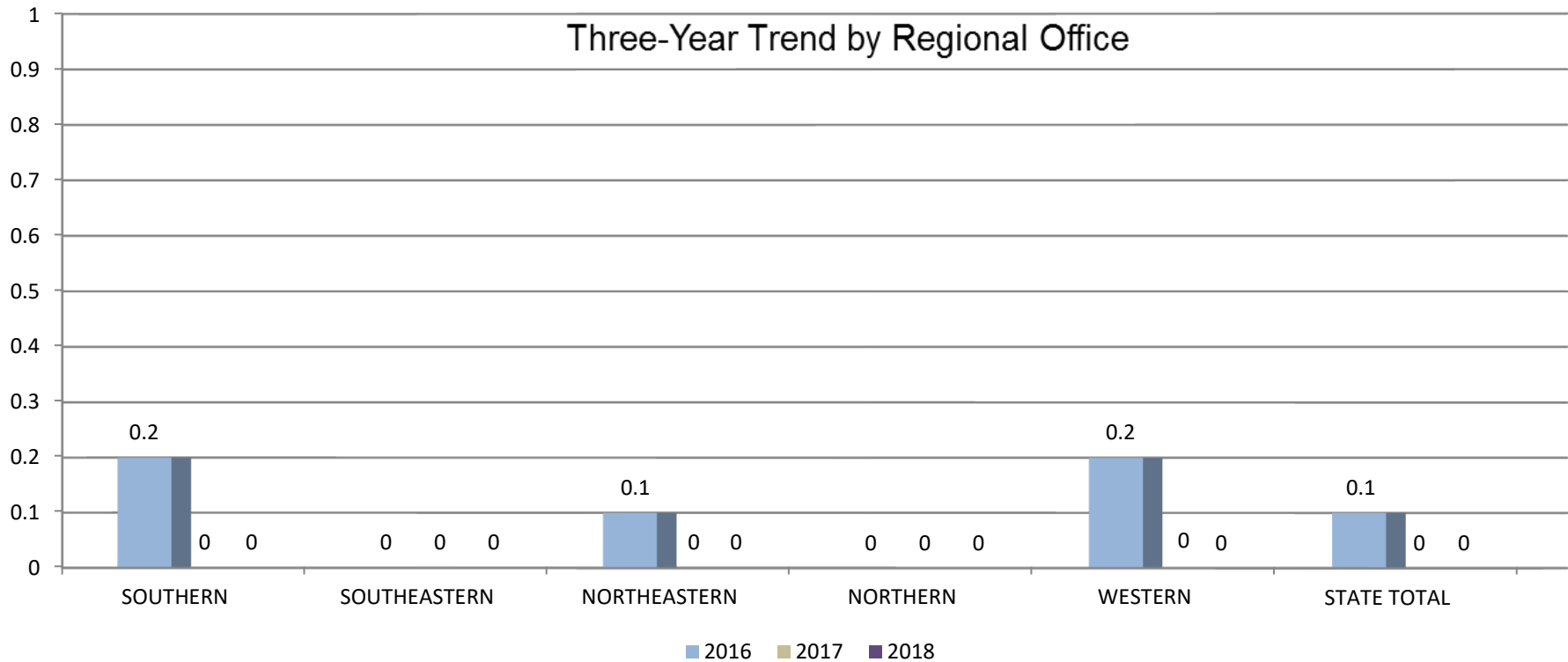
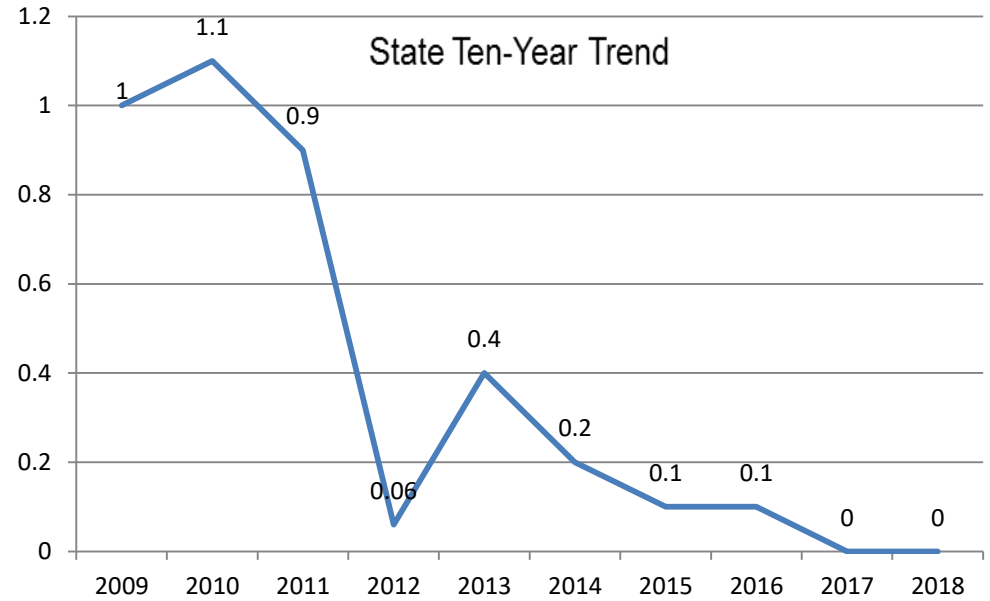

Average Number of State Citations per Recertification Survey

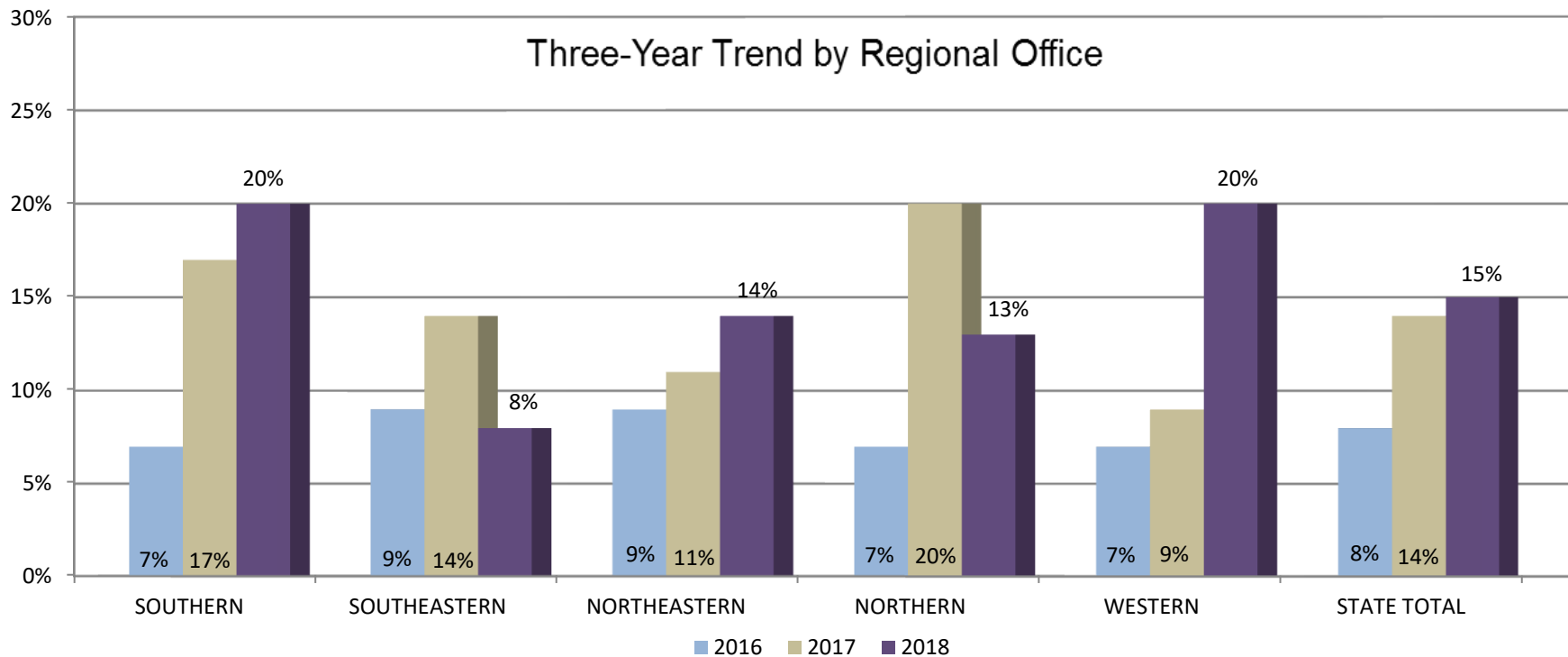
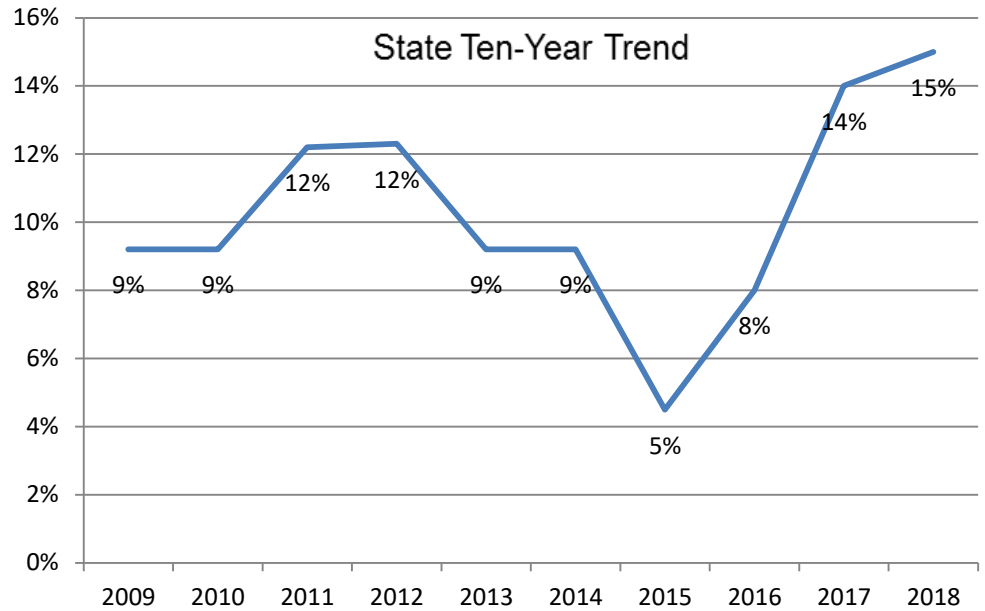

Percentage of Deficiency-Free Recertification Surveys (Health)

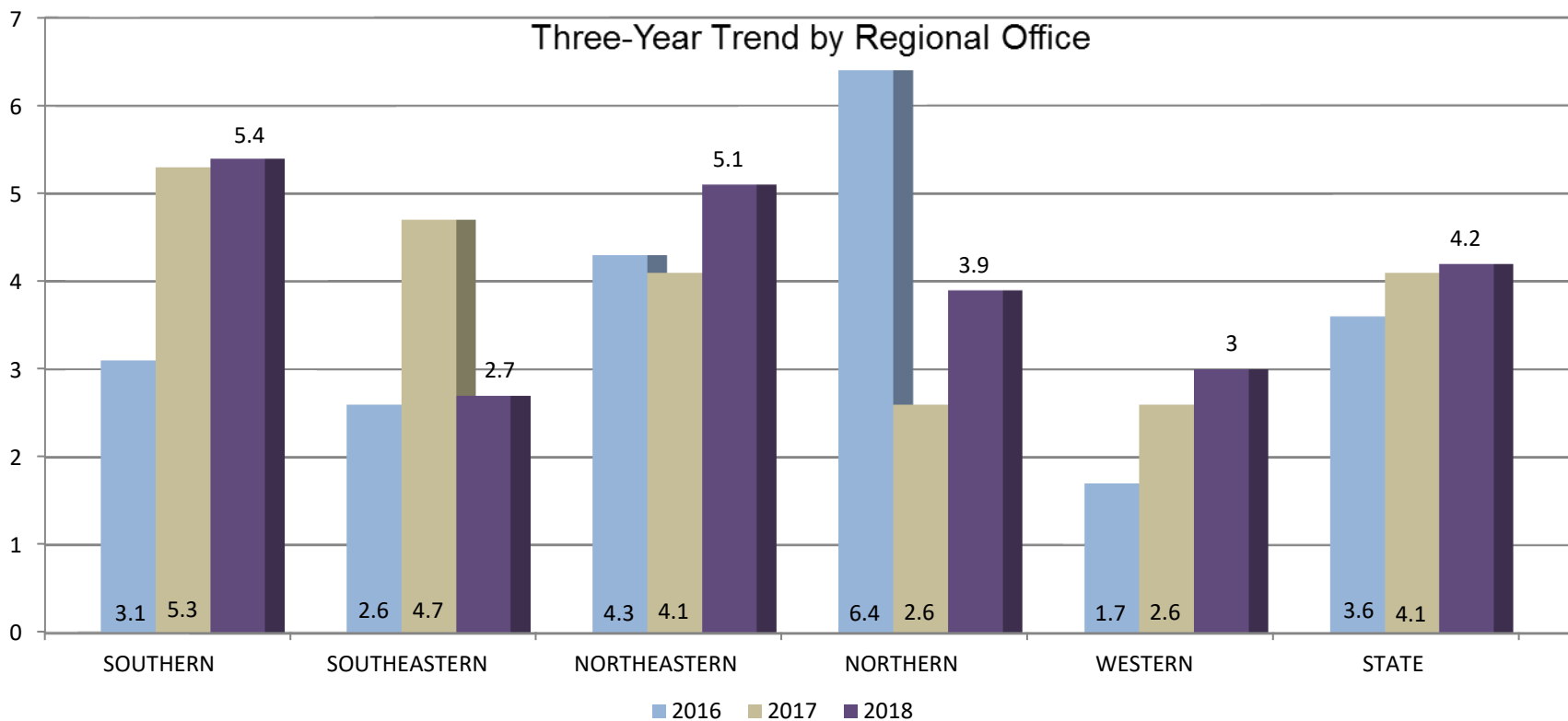
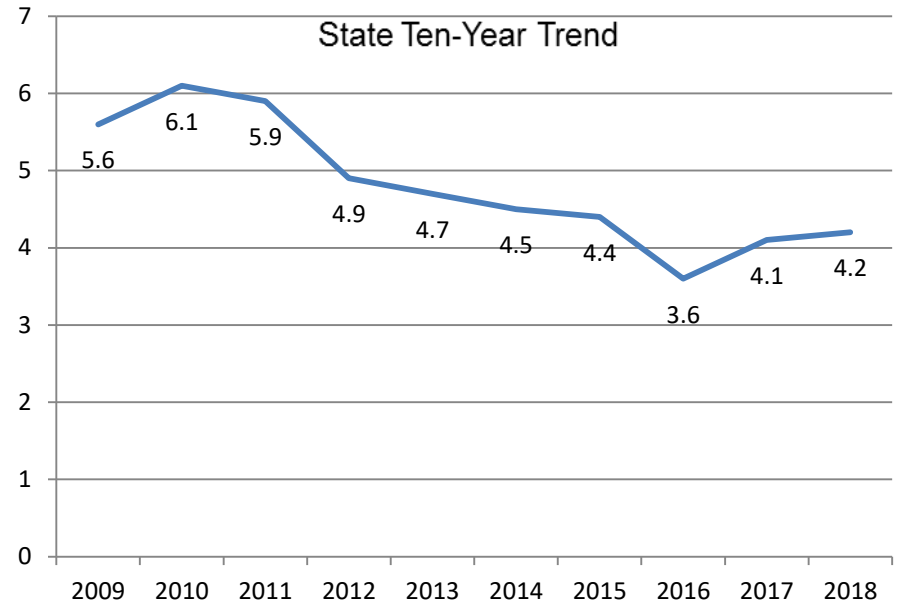

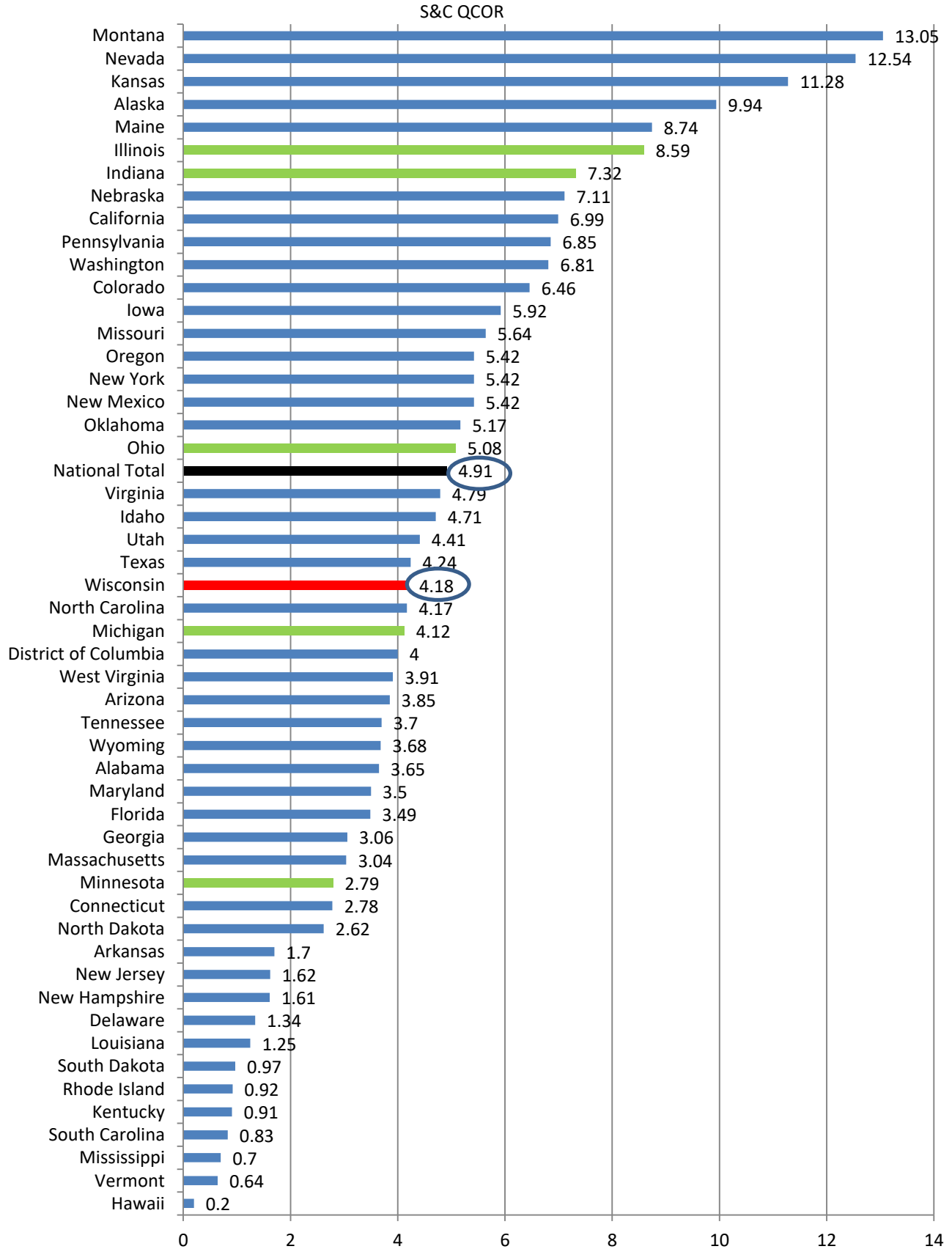
Average Number Life Safety Code Citations per Recertification Survey

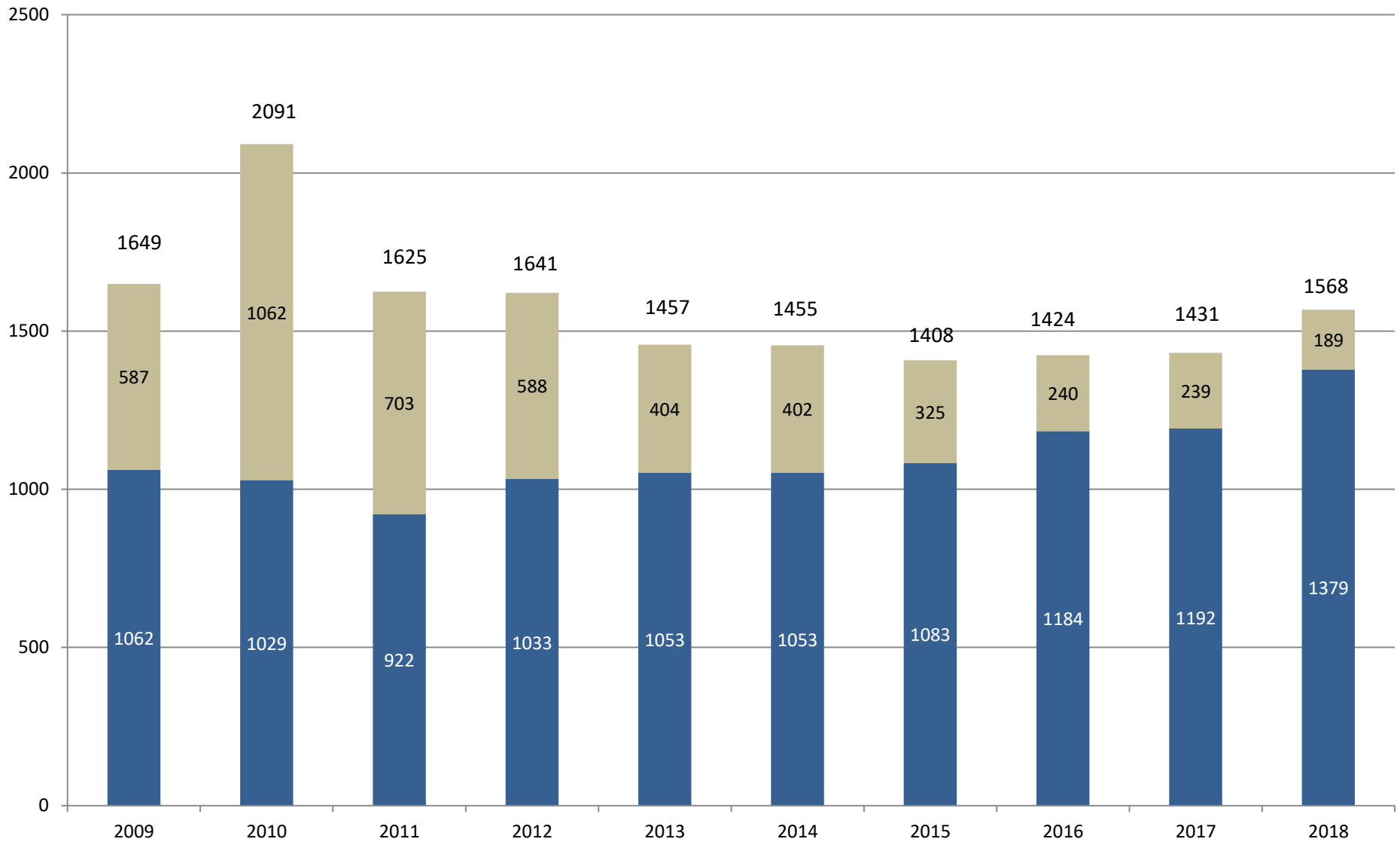

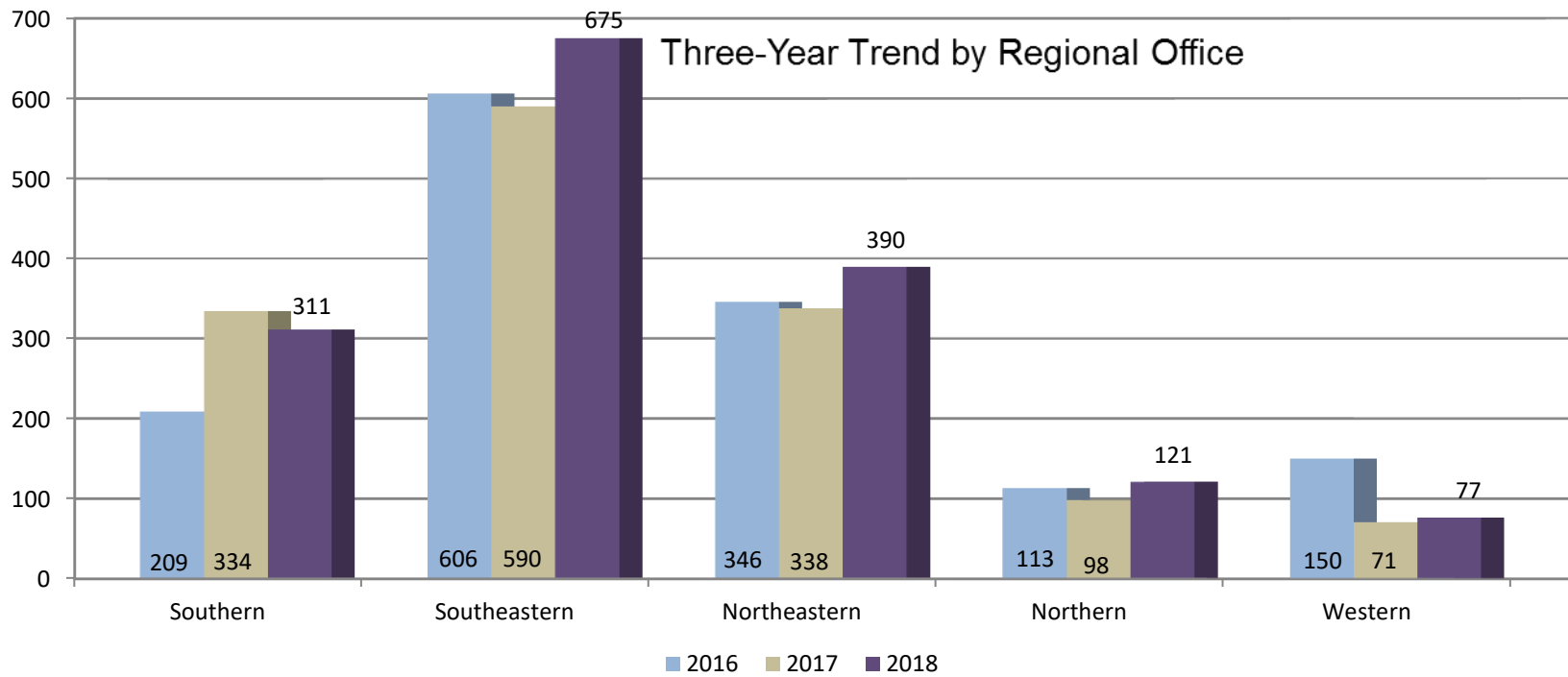
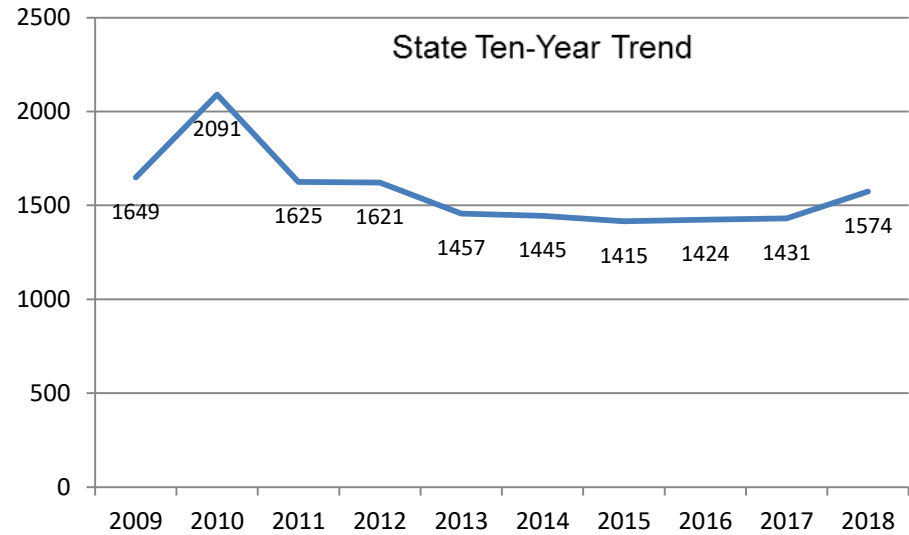

Number of Complaint Intakes

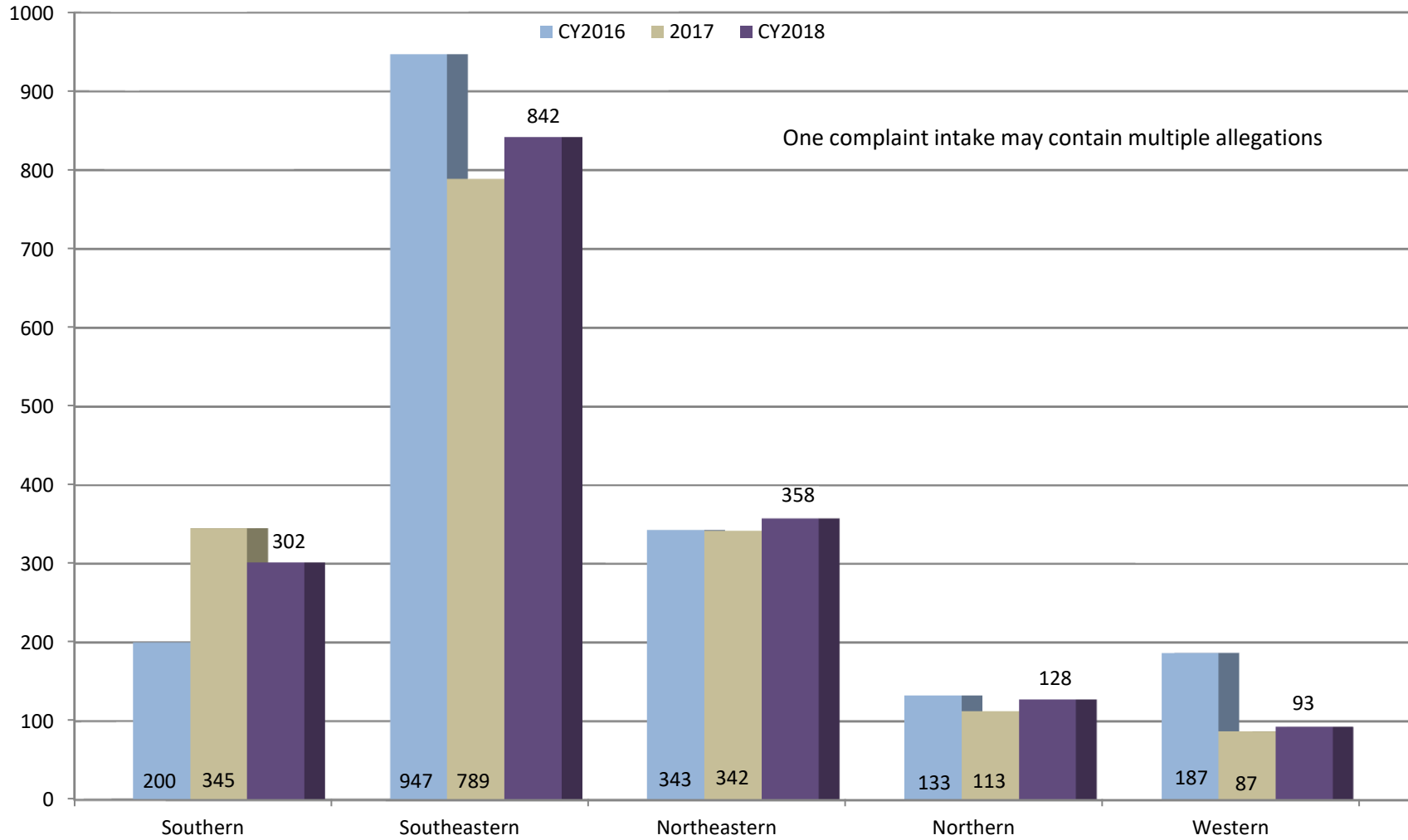

Number of Complaint Allegations Received by Regional Office 2016-2018

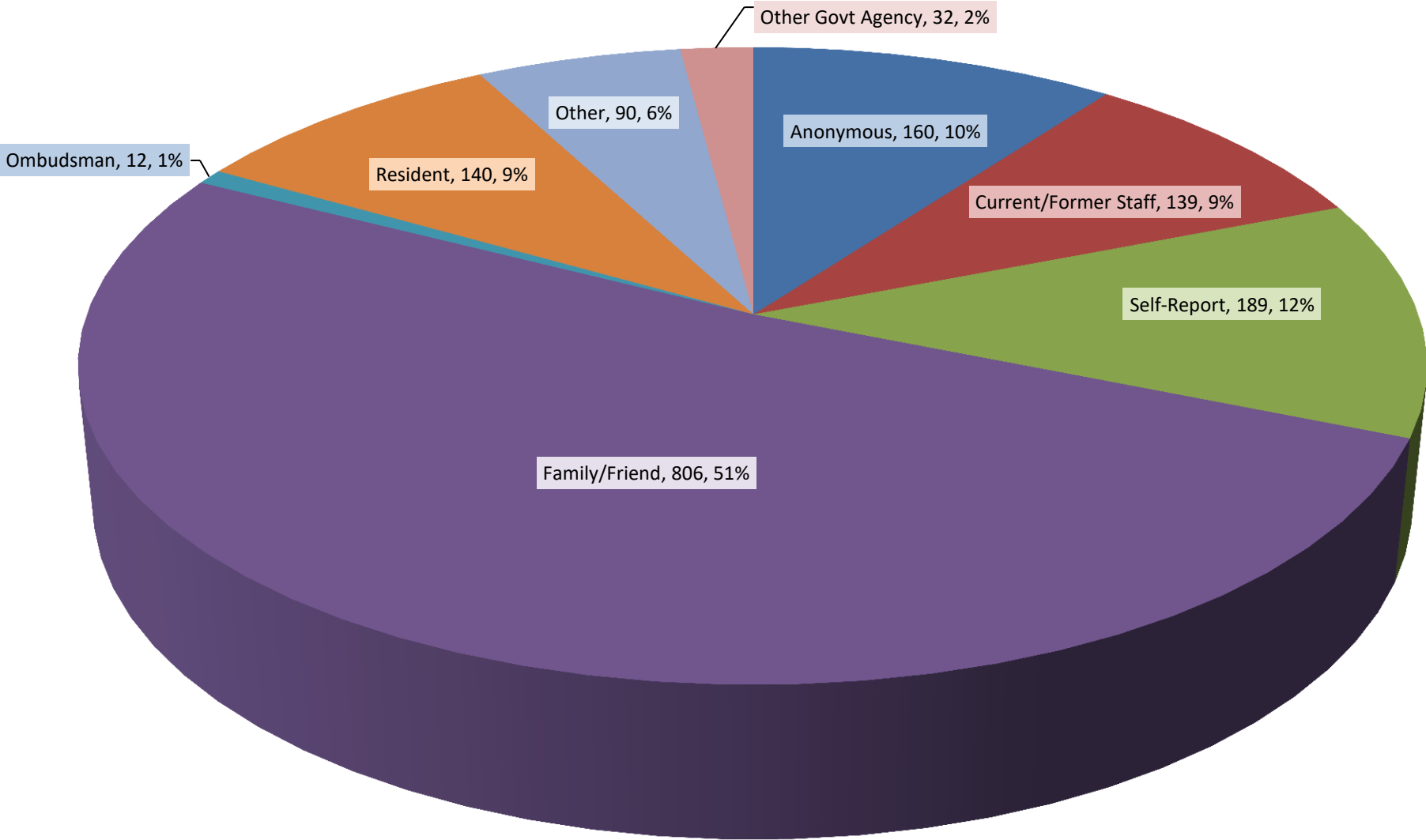

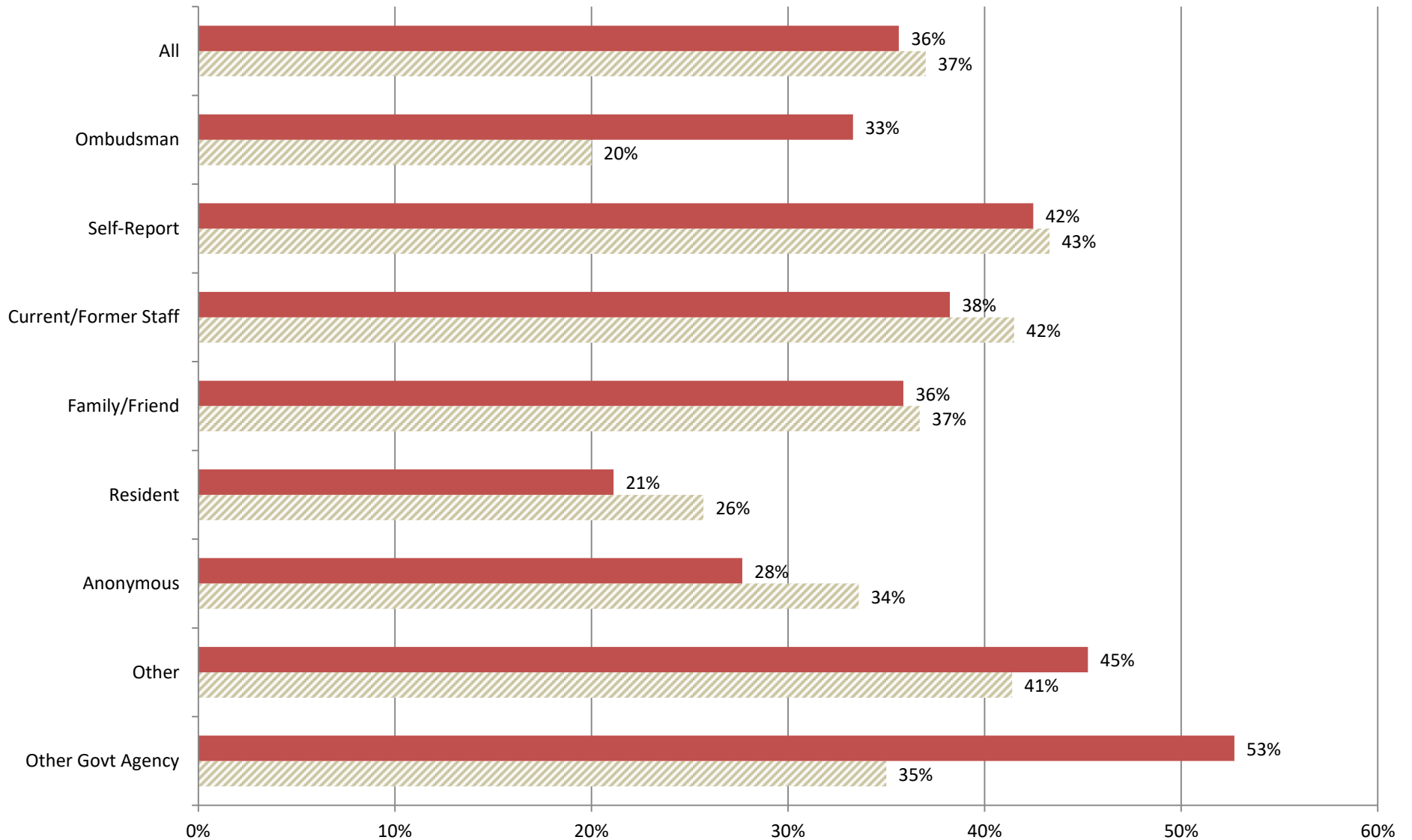




Percentage of Complaints Substantiated by Source of Complaint 2017 and 2018

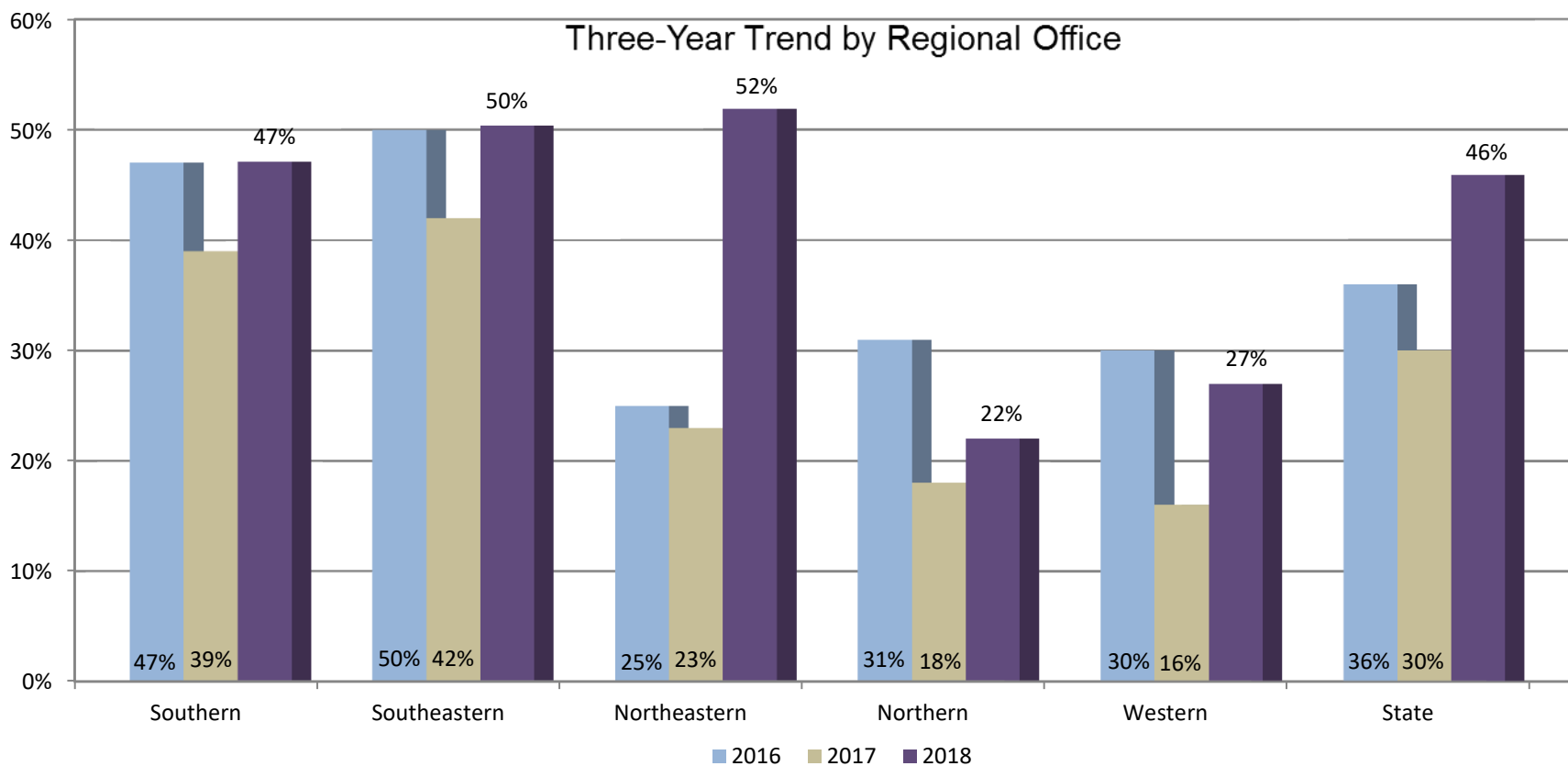
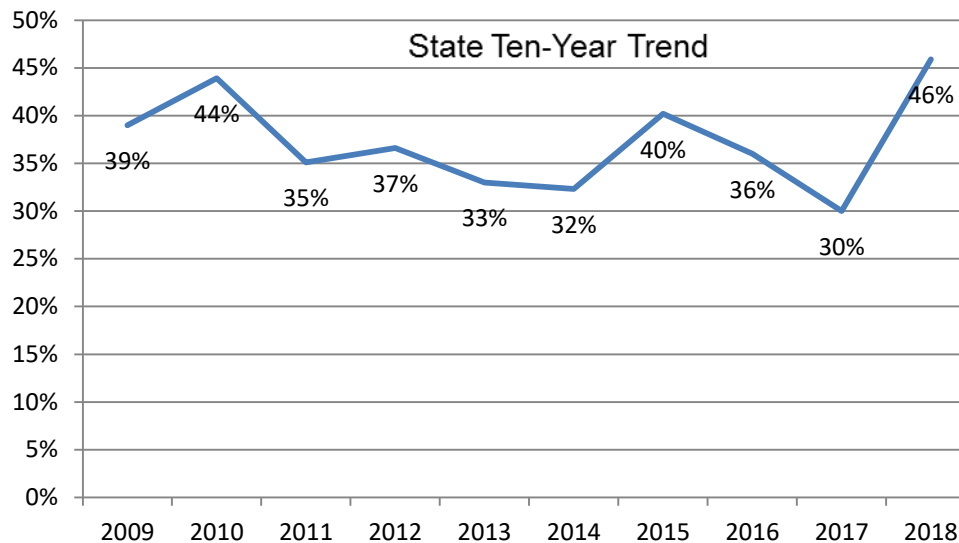

Percentage of Complaint Surveys with Citations

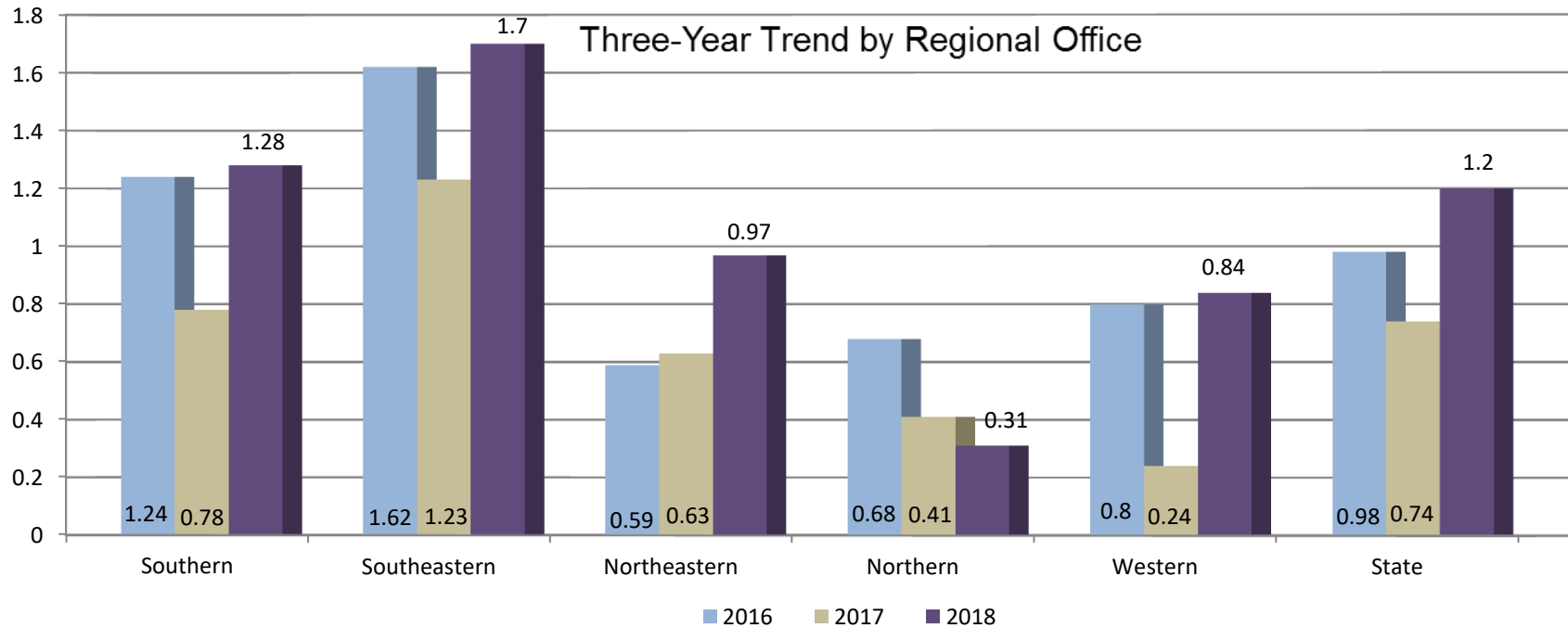
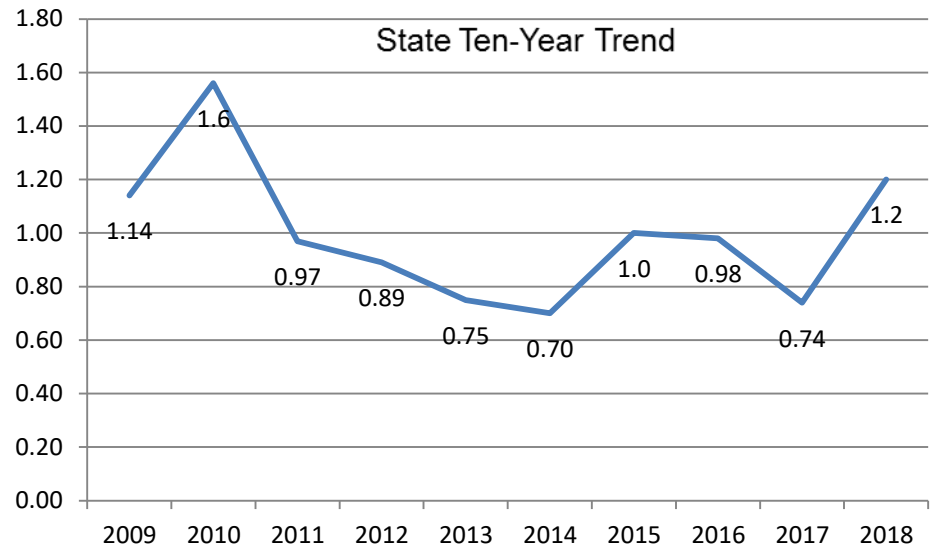

Average Number of Citations per Complaint Survey

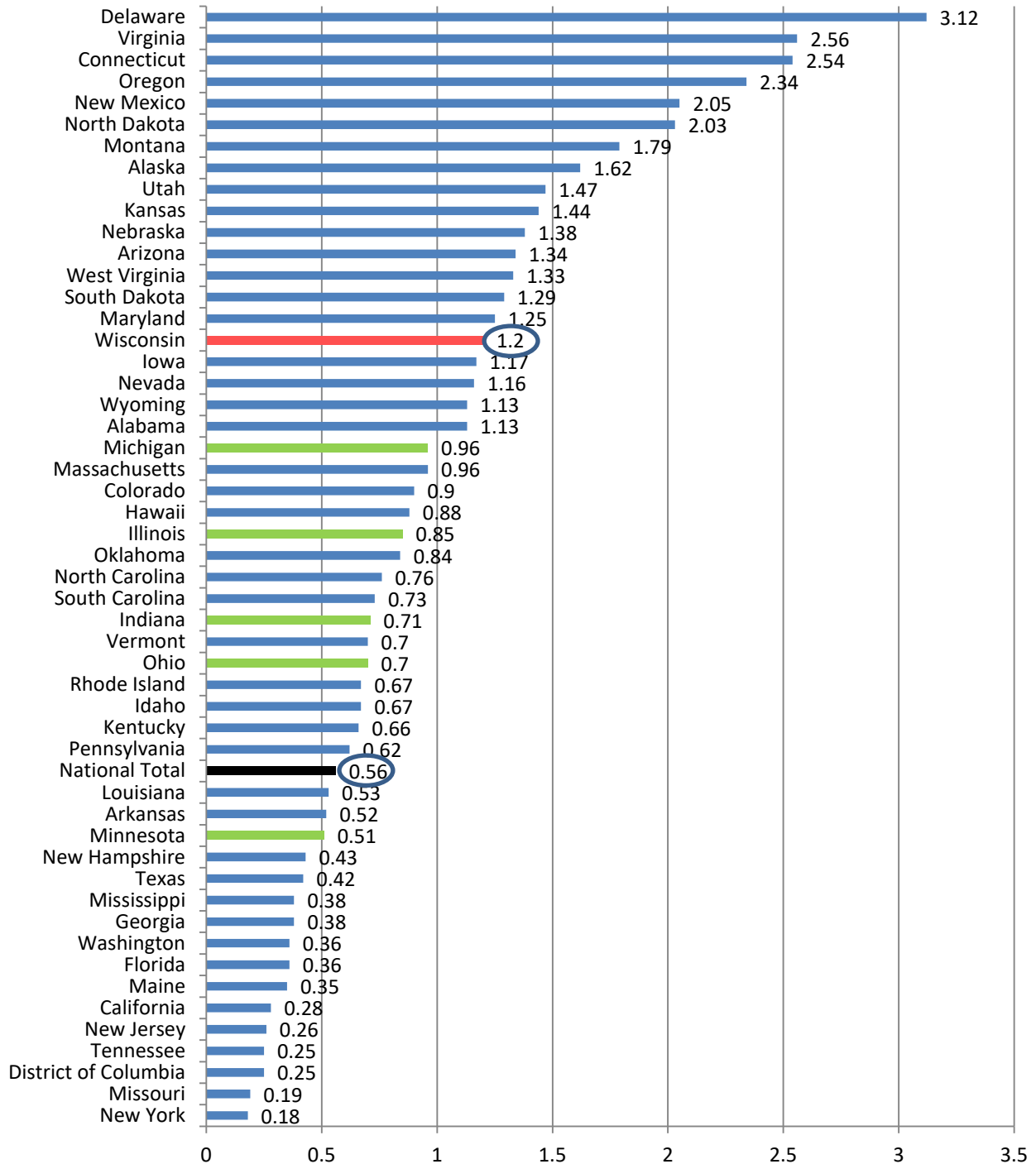

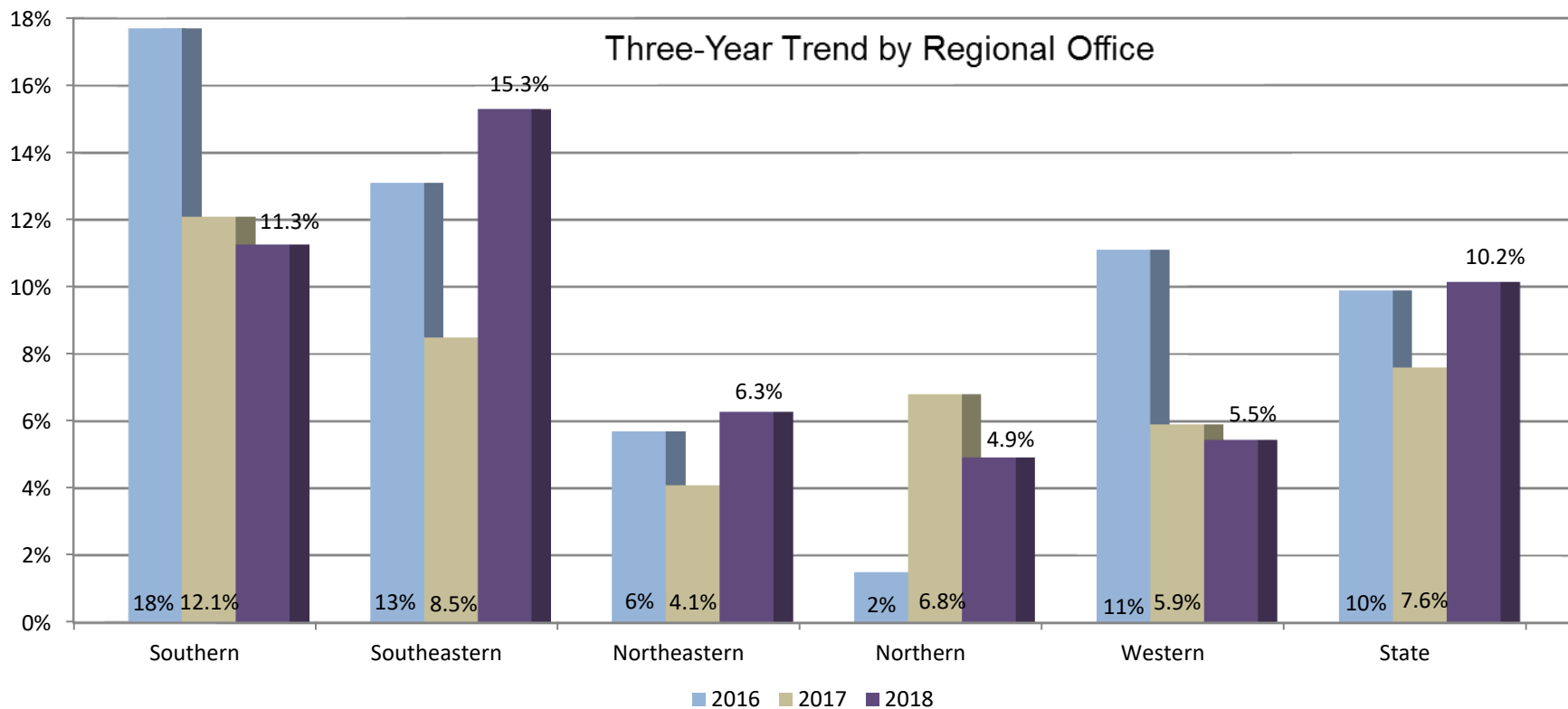
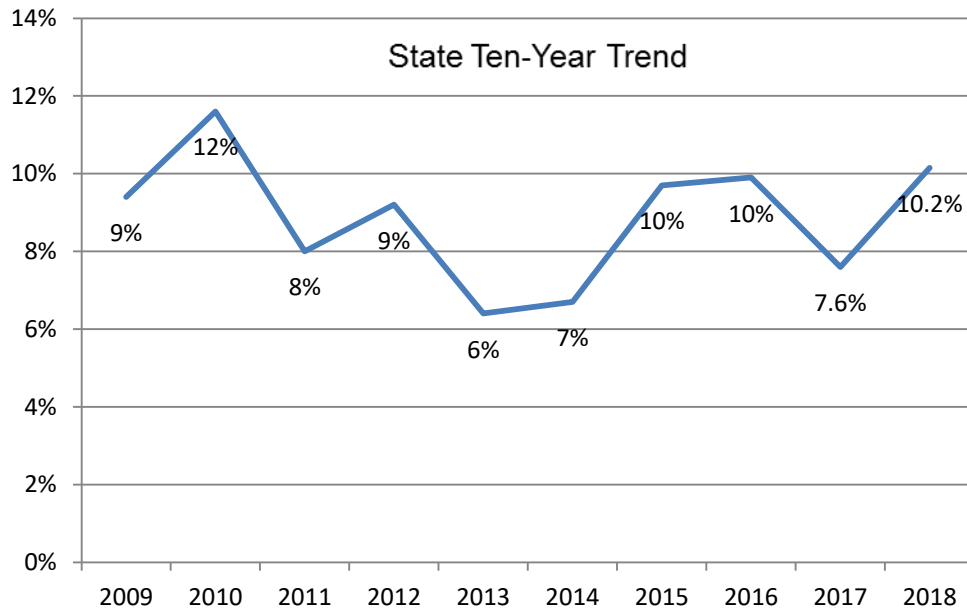

Percentage of Complaint Surveys with Harm or Immediate Jeopardy

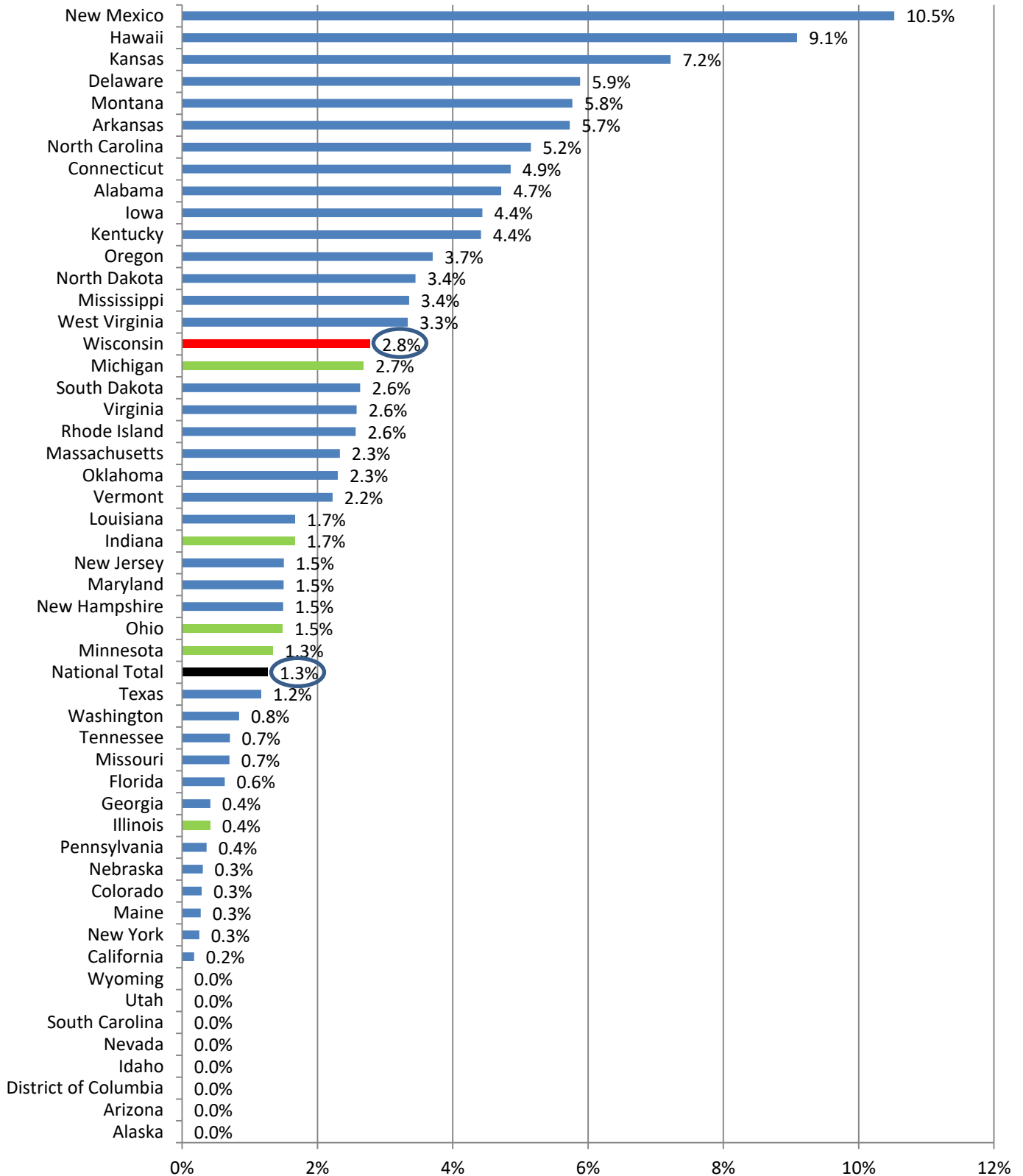

Percentage of Complaint Surveys with Finding of Immediate Jeopardy 2018

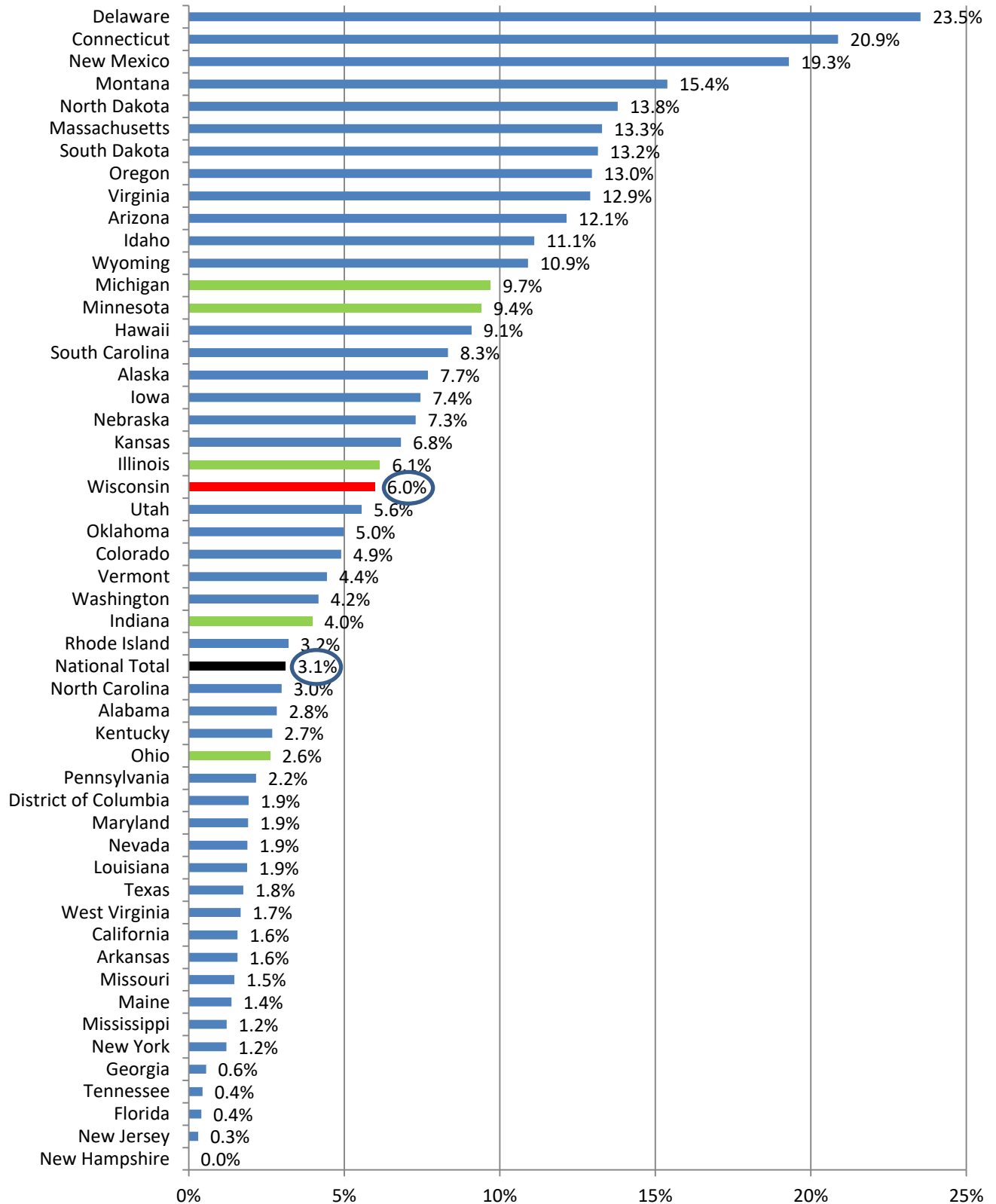

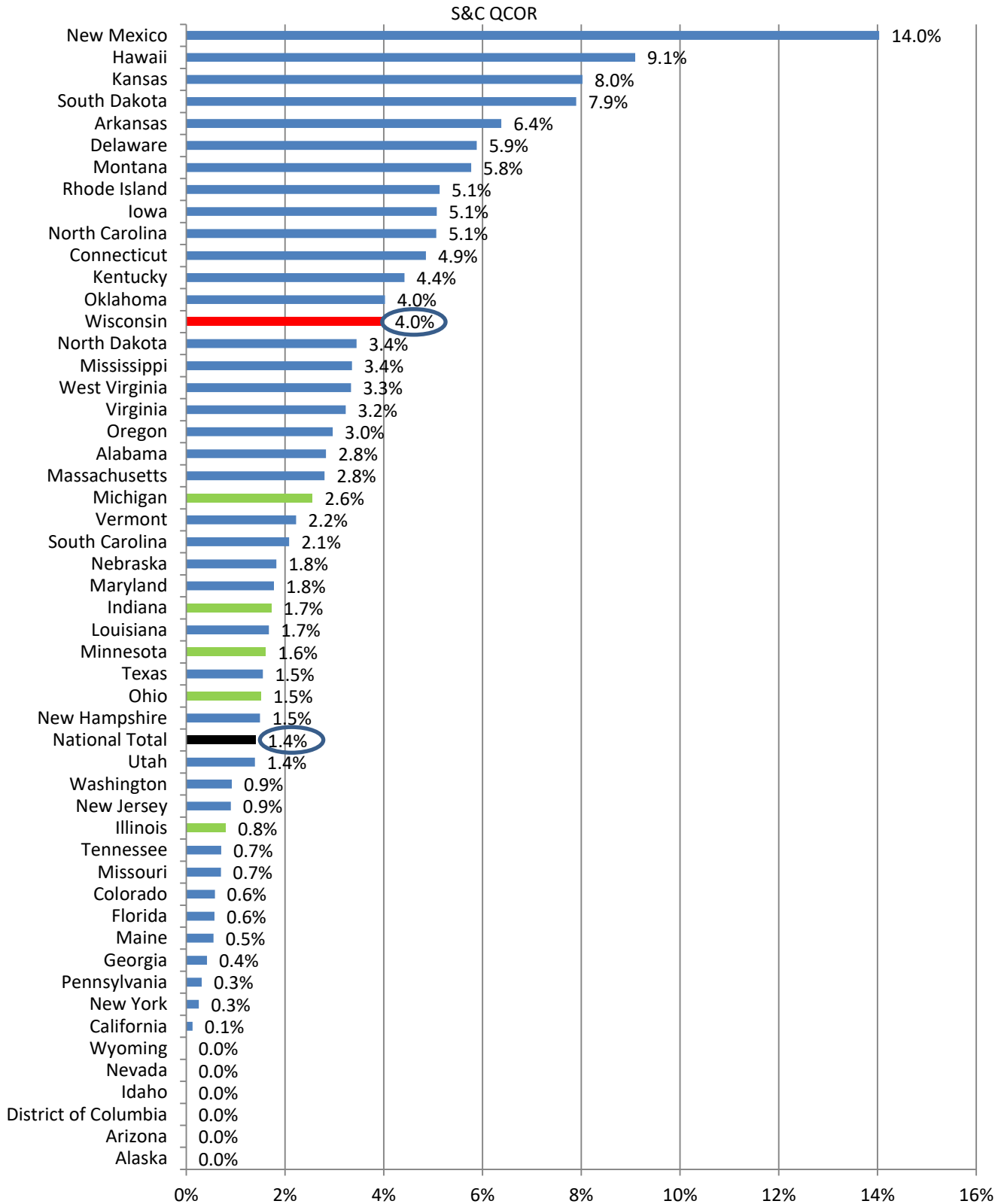
Percentage of Complaint Surveys with Actual Harm Citations Having Highest Scope/Severity

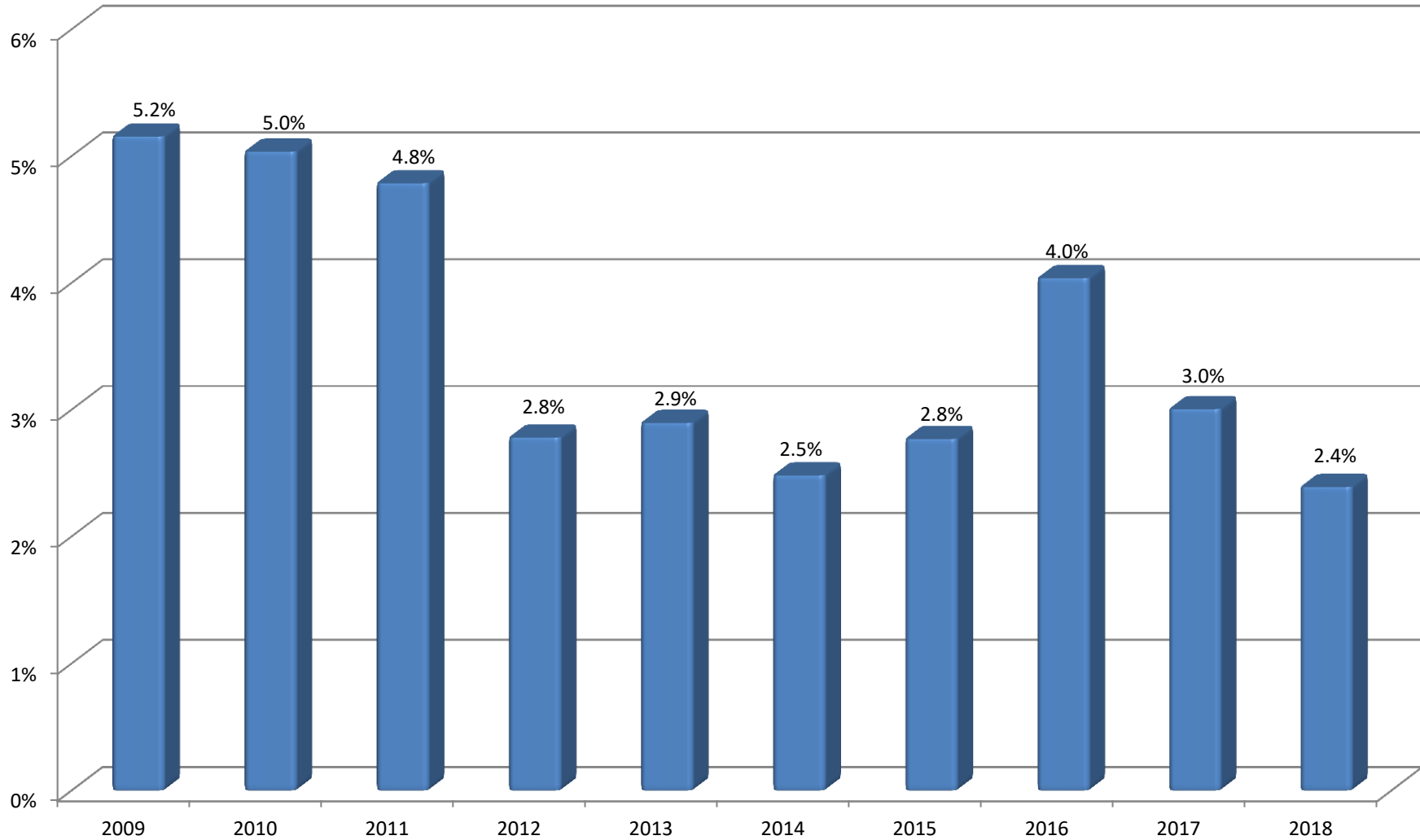
Percentage of Complaint Surveys with Finding of Substandard Quality of Care 2018





Percentage of Federal Health Citations with Request for Informal Dispute Resolution 2009 - 2018

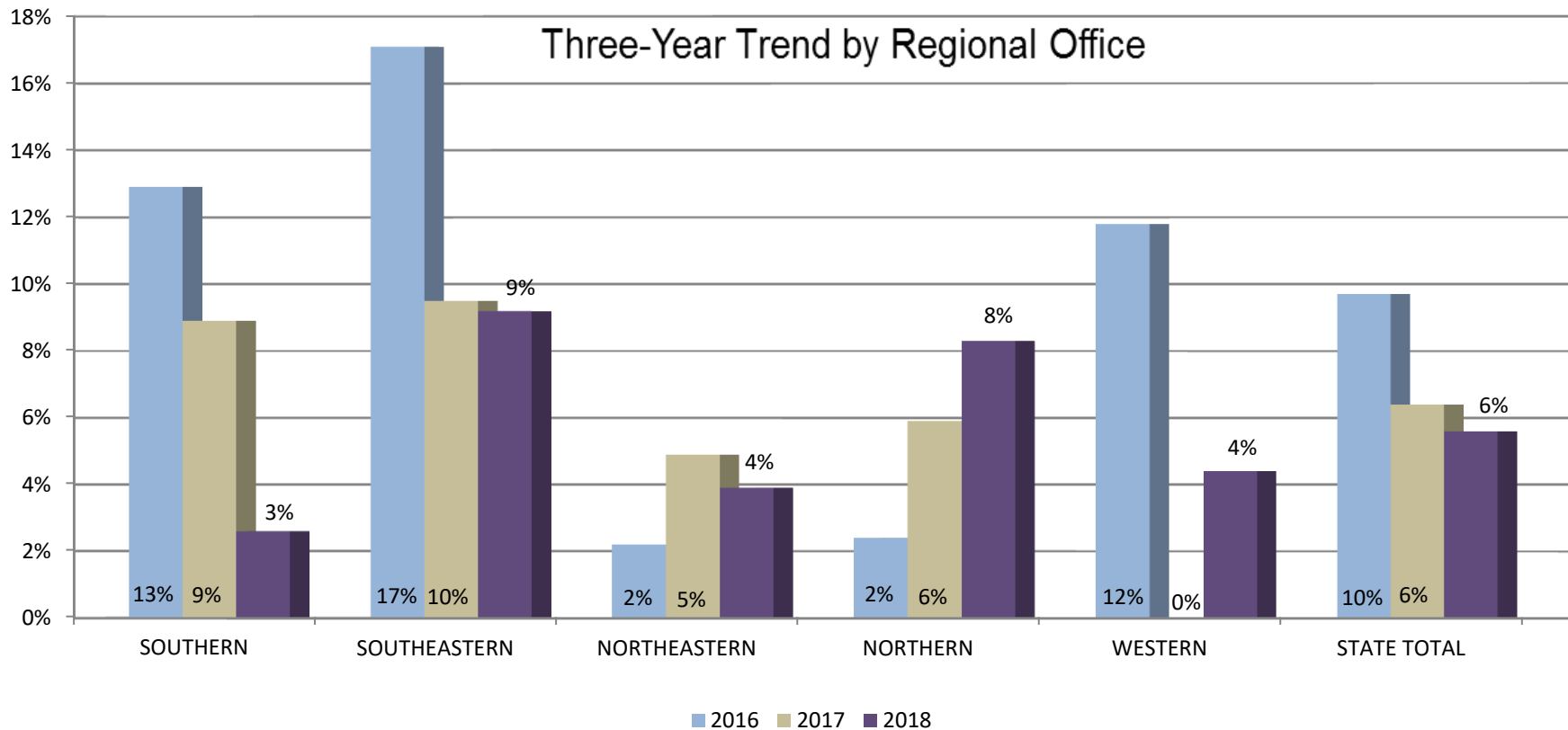
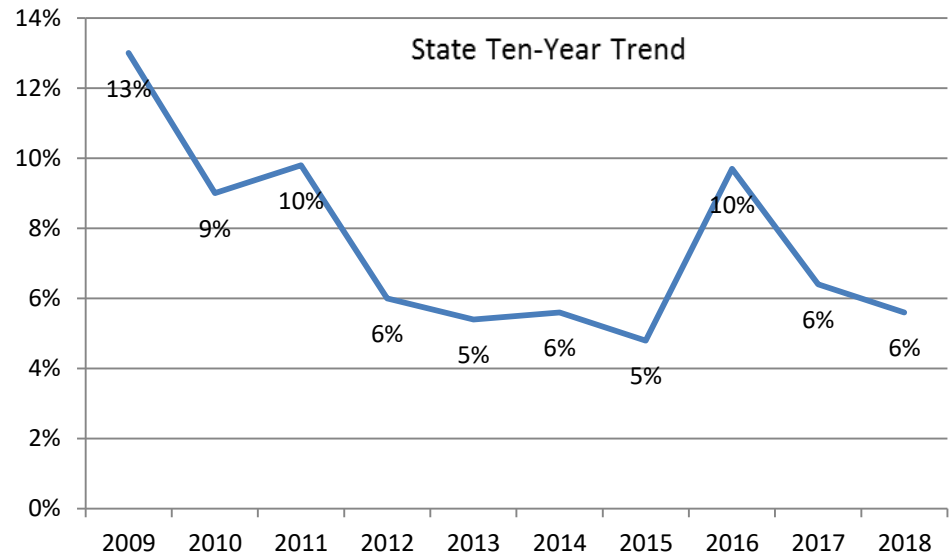

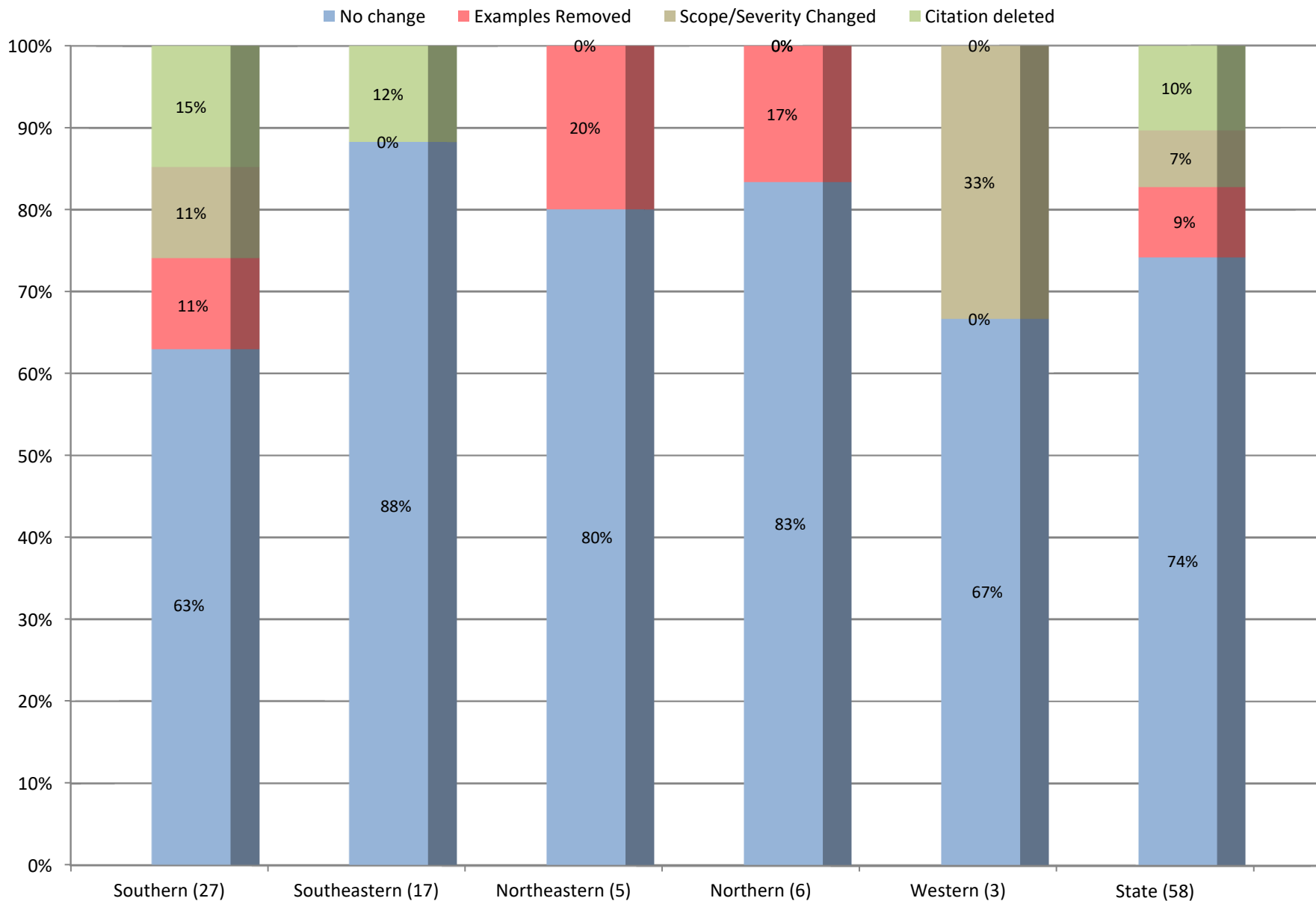
Percentage of Recertification Surveys with Request for Informal Dispute Resolution

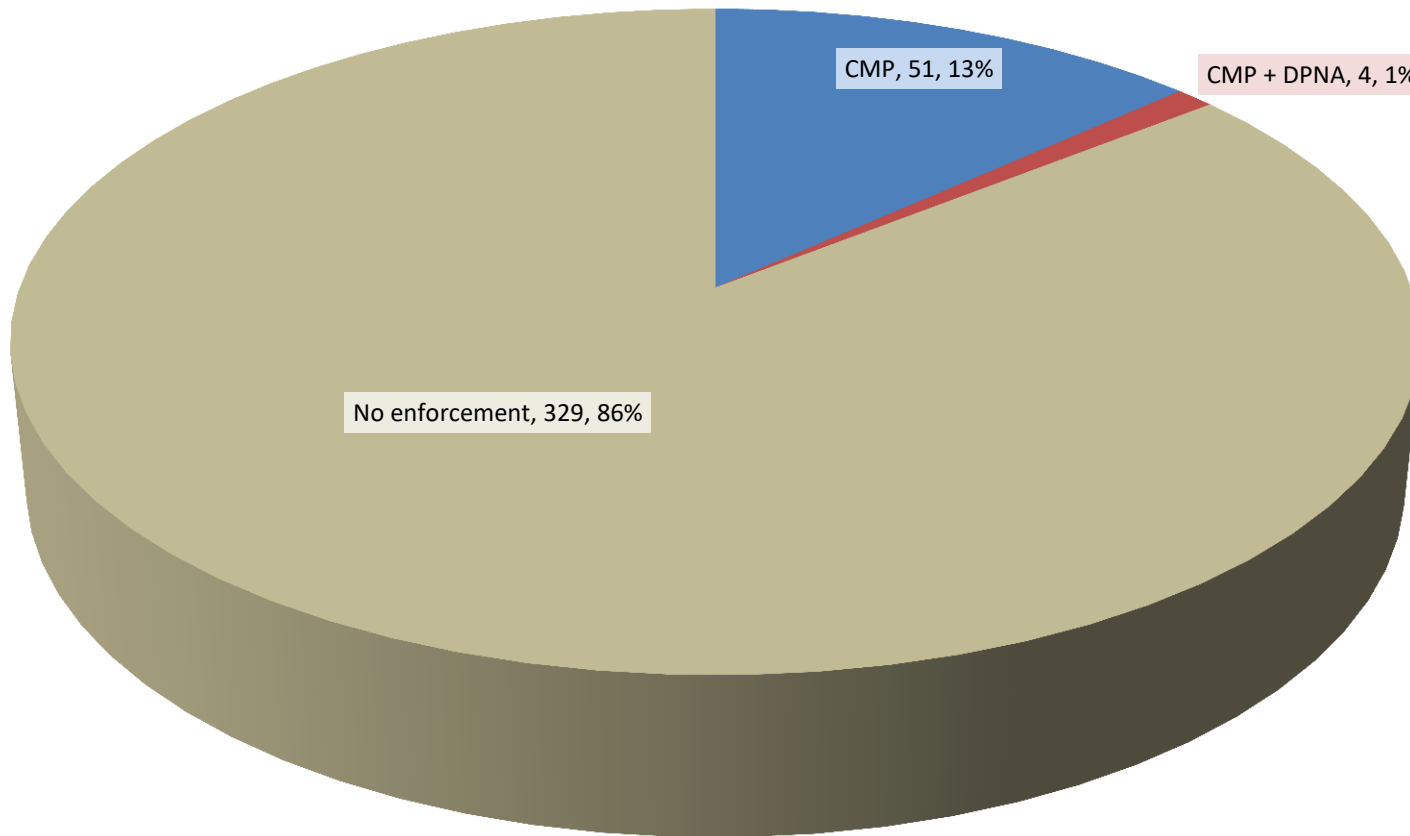
