## Sample Policies & Resources

Resident Rights, CPR, Advance Directives, and Applying for Medicare & Medicaid

In response to member requests, LeadingAge Wisconsin is offering a number of legal documents and sample policies to help you address common issues you encounter. We thank Jack Howard, an Associate with Reinhart Boerner Van Deuren (LeadingAge Wisconsin Legal Counsel) for preparing these documents for us to share with our members.

The resident rights summaries are designed for you to incorporate into the admission agreements you provide for your residents.

Members also have asked for clarification on how residents can receive refunds for previous payments covered by Medicare and Medicaid residents. This requirement calls for a facility to inform residents about how they can receive refunds from the facility for previous payments made by the resident to *the facility* which are covered by Medicare or Medicaid benefits. This ties to the facility's refund policies, which will vary from facility to facility. For example, a facility could agree to directly refund any previous payments made by a resident that are covered by Medicare or Medicaid within a set time period (e.g., 30 days, 60 days, etc.). Alternatively, a facility might choose to instead credit the amount to the resident's next private pay statement. Because different facilities may have different refund policies, and as opposed to a specific refund policy, Reinhart Boerner Van Deuren recommends that facilities include in their refund policies a description of how they will handle refunds of previous payments covered by Medicare and Medicaid residents.

For CBRFs, we offer Quality Improvement Modules for Standardized Assessment, Decision-Making Trees, and ISP Templates. # Is Masking Still Required in AL?

The Public Health Emergency (PHE) is set to expire on May 11, 2023, leaving long-term care

communities waiting and wondering what will come next in regard to masking, testing, and other COVID-19 pandemic-related requirements.

We are hearing that some of our local hospital systems and clinics have relaxed their masking requirements, yet long-term care facilities (LTCFs) are still masked up. Why is this?

According to the Wisconsin Department of Public Health (DPH), current<u>CDC guidance for healthcare settings</u> (including hospitals, clinics, and LTCFs) still recommends source control (masking) when <u>COVID-19 Community Transmission levels</u> are high. LTCFs can opt to relax masking when their Community Transmission levels are not high.

While nothing has been released yet, we are anticipating some changes and/or relaxations to the current recommendations, however, we have not been informed as to what those changes will be. As soon as we learn more, LeadingAge Wisconsin will be sharing and supporting our LTC communities through the transition.

In the meantime, the Bureau of Assisted Living (BAL) is still recommending that assisted living communities continue to follow the most current CDC and DPH recommendations.
